**INDICTMENT**

**September 2018 Term – at Alexandria**

**COUNT 1**

(Production of Child Pornography)

THE GRAND JURY CHARGES THAT:

1. On or about November 27, 2017, within the Eastern District of Virginia, the defendant, LOGAN ROY MCCAULEY, did employ, use, persuade, induce, entice, and coerce minor female N.C. to engage in sexually explicit conduct for the purpose of producing a visual depiction of such conduct, which visual depiction was produced using materials that had been mailed, shipped, and transported in and affecting interstate and foreign commerce by any means; to wit: a video with file name IMG\_3039.mov depicting sexual intercourse with N.C. that was produced using an Apple iPhone.

(In violation of Title 18, U.S. Code, Section 2251(a) & (e).)

**FORFEITURE NOTICE**

2. The allegations contained in Counts 1 of this Indictment are hereby re-alleged and incorporated by reference for the purpose of alleging forfeiture pursuant to Title 18, U.S. Code, Section 2253(a).

3. Pursuant to Federal Rule of Criminal Procedure 32.2(a) the defendant, LOGAN ROY MCCAULEY, is hereby notified that if convicted of a violation of 18 U.S.C. § 2251(a), he shall forfeit to the United States under 18 U.S.C. § 2253(a), the following:

a. any and all matters which contain visual depictions described in 18 U.S.C. § 2251, 2251A, 2252A, 2252B, or 2260, or any book, magazine, periodical, film, videotape, or other matter which contains any such visual depiction, which was produced, transported, mailed, shipped, or received in violation of Title 18, Chapter 110 of the U.S. Code;

b. any property, real or personal, constituting or traceable to gross profits or other proceeds the defendant obtained from such offense; and

c. any property, real or personal, used or intended to be used to commit or promote the commission of such offense, or any property traceable to such property.

4. The property subject to this forfeiture notice includes, but is not limited to, the following: an Apple iPhone (Model A1778; FCCID BCG-E3091A).

(Pursuant to Title 18, U.S. Code, Section 2253(a) and Fed. R. Crim. P. 32.2(a).)


