#### **Broad Support for Justice Department's Updated Guidance on Improving Law Enforcement Response to Sexual Assault and Domestic Violence by Identifying and Preventing Gender Bias**

WASHINGTON – Last week, the Department of Justice announced [updated guidance](#), “Improving Law Enforcement Response to Sexual Assault and Domestic Violence by Identifying and Preventing Gender Bias,” designed to help law enforcement agencies (LEAs) improve their response to sexual assault and domestic violence.
