

## Legal Assistance for Victims Summary Data Sheet

The Summary Data Sheet must be completed and submitted as an attachment with your application under the Additional Application Components section in JustGrants.

1. Provide the following information for the grant point-of-contact, who must be an employee of the applicant. **Name, title, address, telephone number, and email address.**
2. Is the applicant (the organization whose unique entity identifier is being used for the application) serving as a fiscal agent? A fiscal agent is an entity that does not participate in implementation of the project and passes all funds through to subrecipients, conducting minimal administrative activities. The fiscal agent must be an eligible applicant for the program. **(Yes or No. If yes, list all subrecipients.)**

*Note: A fiscal agent applicant must include a statement acknowledging that it will be responsible for all applicable statutory, fiscal, and programmatic requirements, including those of 2 C.F.R. Part 200, as well as all project deliverables.*

3. Has the applicant expended \$1,000,000 or more in federal funds in the applicant's past fiscal year? **(Yes or No. If yes, specify the end date of the applicant's fiscal year.)**
4. Does the application propose a project designed to advance any of the following public-safety priorities:
  - A. Combatting human trafficking and transnational crime, particularly crimes linked to illegal immigration, transnational criminal organizations, and cartel operations, including projects that strengthen law enforcement investigation and prosecution while supporting safety and justice for trafficking victims who have also suffered domestic violence, sexual assault, dating violence, and/or stalking. **(Yes or No)**
  - B. Projects dedicated to direct provide victim services and/or criminal justice responses—including investigation, arrest, prosecution, and enforcement of protective orders—particularly in small towns and rural, remote, and Tribal communities. **(Yes or No)**
5. Is the applicant a nonprofit organization that holds money in offshore accounts for the purpose of avoiding paying the tax described in section 511(a) of the Internal Revenue Code? **(Yes or No)**
6. Is the applicant a nonprofit organization that uses the Internal Revenue Service's three-step safe-harbor procedure to establish a rebuttable presumption that its executives' compensation is reasonable? What is the name of the nonprofit, nongovernmental or Tribal organization (or Tribal government with a victim services division or component) that provides direct services to victims of domestic violence, dating violence, sexual assault and/or stalking? (Note: this may be the lead applicant or a project partner.)
9. What is the name of the nonprofit organization, nongovernmental or Tribal organization (or Tribal government program) that has experience and expertise providing legal representation by an attorney to victims of domestic violence, dating violence, sexual assault, and/or stalking? (Note: this may be the lead applicant or a project partner and may be met by experience providing lay legal representation in Tribal court for Tribal applicants.)
10. Will the project help victims who live on Tribal lands? **(Yes or No. If yes, list percentage of project activities.)**
11. Will the project support pro bono work? **(Yes or No. If yes, list percentage of project activities.)**
12. Will the project focus primarily or solely on providing legal assistance to victims of sexual assault? **(Yes or No)**
  - What percentage of proposed activities will focus on providing legal assistance to victims of sexual assault?
    - More than 50% or of grant-funded activities will focus on providing legal assistance for victims of sexual assault.
    - 100% of grant funded activities will focus on providing legal assistance for victims of sexual assault.
