
About the OVW Tribal Sexual Assault Services Program page 5

The Tribal Sexual Assault Services Program (TSASP) supports efforts to create, maintain, and expand sustainable sexual assault services provided by Tribes, tribal organizations, and nonprofit tribal organizations within Indian country and Alaska Native villages. TSASP supported projects provide intervention, advocacy, accompaniment (e.g., accompanying victims to court, medical facilities, or police departments), support services, and related assistance for adult, youth, and child victims of sexual assault, non-offending family and household members of victims, and those collaterally affected by the sexual assault.

Register with SAM.gov, Monday, April 10, 2023.
Grants.gov deadline, Monday, May 1, 2023 – 11:59 p.m. EST
Just Grants deadline, Thursday, May 4, 2023 – 8:59 p.m. EST
Late submissions are not accepted except in very limited circumstances. Refer to pages 32-34 of the solicitation for more information.

- 2. Budget Detail Worksheet and Budget Narrative
- 3. Document(s) Demonstrating Authority to Apply (not required for Indian Tribes)
- 4. Data Requested with Application (formerly the Summary Data Sheet)
- 5. Pre-Award Risk Assessment

Eligibility

Current grantees with 50% or more of funds remaining in the existing award, as of March 31, 2022, may not be considered for funding, or may receive a reduced award amount if selected for funding in FY 2023.

Project Types pages 8-9

- Standard project
 - Applicants must propose activities under the TSASP statutory purpose areas.
- Improving Tribal Responses to Sexual Assault (ITRSA) Capacity-Building project
 - Applicants will engage in a comprehensive assessment process that identifies the strengths and gaps of their community's responses to sexual assault
 - Following the assessment, a customized project implementation plan will be developed in consultation with an OVW-designated Technical Assistance Provider(s).

Note: OVW retains discretion to move standard project applicants into ITRSA or vice versa.

Purpose Area page 6

Funds under this program must be used to support the establishment, maintenance, and expansion of programs and projects within Indian country and Alaska native villages to provide intervention and related assistance to those victimized by sexual assault.

Intervention and related assistance includes:

- Crisis intervention services and referral.
- Accompaniment and advocacy
- Short-term individual and group support services, service coordination
- Information and referral
- Culturally specific services
- Development and distribution of materials related to the services 1-5.

Purpose Area (continued) **DIRECT VICTIM SERVICES** to survivors of sexual violence and their non-offending family/household members.

Not restricted by **GENDER** or **AGE** or when the **SEXUAL ASSAULT HAPPENED**.

Pay attention to what is not listed in the purpose areas and what is out of scope.

TSASP Out of Scope Activities page 7 Activities focused on prevention efforts and public education.

Criminal justice-related projects, including law enforcement, prosecution, courts, and forensic interviews.

Providing domestic violence or dating violence victim services unrelated to intimate partner sexual violence.

Sexual Assault Forensic Medical Examiner programs.

Sexual Assault Response Team coordination.

Providing training to allied professionals and the community.

If your application proposes out-of-scope activities, points may be deducted from your application score, or it may be eliminated from consideration entirely.

Victim Safety and Confidentiality pages 6-7 >OVW does not fund activities that jeopardize victim safety, deter or prevent physical or emotional healing for victims, or allow offenders to escape responsibility for their actions.

Refer to the <u>Solicitation Companion Guide</u> on the OVW website for the full list of activities.

TSASP-specific activities include:

- Procedures or policies that deny individuals access to services based on their relationship to the perpetrator.
- Couples counseling, family counseling, or any other joint victimoffender counseling as a routine or required response to sexual assault.
- Materials that are not tailored to the dynamics of sexual assault or to tribal communities.

OVW Priority Area page 6

In FY 2023, OVW is interested in supporting the following priority area. Applications proposing activities in the following areas will be given special consideration.

• Improve outreach, services, and support for survivors of sexual assault from underserved communities, particularly LGBTQ and immigrant communities.

What's New This Year?

The Violence Against Women Act Reauthorization Act of 2022 added "direct payments" to the list of items that may constitute "intervention and related assistance" for victims of sexual assault under the TSASP statute.

No more web-based documents or surveys. Specifically, the data-requested with application and budget will be attachments. Application Information The following are major elements of the application and are required to be uploaded as attachments in JustGrants:

- 1. Proposal Narrative
- 2. Budget Detail Worksheet and Budget Narrative
- 3. Document(s) Demonstrating Authority to Apply (not required for Indian Tribes)
 - a. Tribal Consortium documentation of authority (page 28)
 - b. Tribal Organization or Nonprofit Tribal Organization letter of support (page 29)

Applications that do not include all the following documents will be considered substantially incomplete, which may result in removal from consideration for funding, or if awarded, may result in award conditions precluding access to funds.

Proposal Narrative pages 20-23

STANDARD

Purpose of the Proposal, 20 points, describes the need for the project

What Will Be Done, 45 points, describes what you will do

> Who Will Implement, 20 points, describes the expertise of key individuals and organizations

ITRSA CAPACITY BUILDING

- What Will Be Done, 80 points, describes:
 - Service Area
 - New or Expanded Sexual Assault Services
 - Victim Safety Needs
 - Expertise of Key Individuals and Organizations and

Note: It can be helpful to use each question as a section header and to respond to each question.

Budget Detail Worksheet and Budget Narrative pages 23-26 The award period is 36 months

OVW required TA and Travel - \$35,000 MINIMUM

Include funds to address accessibility needs

Compensate all project partners

Upload the budget as an excel document, and include a budget narrative

Document(s) Demonstrating Authority to Apply pages 28-29 >Not required for Indian Tribes

Tribal consortiums must provide demonstration of authority to apply from each member.

Tribal organizations and Tribal nonprofits must provide a letter(s) of support LOS from the tribe(s) to be served.

A sample letter is on the <u>OVW resources for applicants</u> website.

Note: make sure your letter has all the pieces noted in the solicitation.

Grants Management Financial Division Documents pages 17-19 and 27

Data Requested with Application

- Upload answers as attachment in the proposal narrative section
- Single Audit (threshold and fiscal year)
- IRS three-step safe-harbor procedure, Executive Compensation
 - Sample Disclosure Letter
 - Address all four parts

Pre-Award Risk Assessment

- Upload attachment in the proposal narrative section.
- Eleven questions; Multiple parts to each question
- Most Common issues:
 - Brief list of policies and procedures not provided
 - Budgeted vs. Actual process not provided
 - Record Retention policy not provided
 - Knowledge of rules and regulations

Applications must include a proposal narrative, a budget detail worksheet and narrative, and if necessary, documents demonstrating authority to apply.

>LOAs that do not contain signatures are considered incomplete.

>Utilize the Application Checklist (page 40) when submitting application.

Ensure that project designs and budgets account accessibility issues.

Tips (continued)

> Plan ahead and give yourself time to develop the application.

>Submit application as far in advance of the deadline as possible.

- Make the application easy to read and follow for all of the reviewers.
- JustGrants only accepts three formats, Microsoft Word, PDF, or Text Document format.

>Print out your application before submitting.

Number the pages in the application, specifically the project narrative.

Monitor your email for alerts that the application was submitted successfully or rejected.
