

# Executive Grant of Clemency

TO ALL WHOM THESE PRESENTS SHALL COME, GREETING:

*WHEREAS* **ANTONIO GUERRERO** (Reg. No. 58741-004) was convicted in the United States District Court for the Southern District of Florida (Docket No. 1:98CR0721-004) on an indictment charging violations of Sections 371, 794(c), and 951 of Title 18, United States Code, for which a total effective sentence of life imprisonment, five years of supervised release, and a special assessment of \$300 was imposed on December 27, 2001; and

*WHEREAS*, following appeal, the said **ANTONIO GUERRERO** was resentenced on October 13, 2009, to a total effective sentence of 262 months of imprisonment, five years of supervised release, and a special assessment of \$300; and

*WHEREAS* the said **ANTONIO GUERRERO** has been continuously confined since September 12, 1998; and

*WHEREAS* it has been made to appear that the ends of justice, foreign policy considerations, and the national security of the United States require that the aforesaid sentence not be served in its entirety;

NOW, THEREFORE, BE IT KNOWN that I, BARACK OBAMA, President of the United States of America, pursuant to my powers under Article II, Section 2, clause 1, of the Constitution, and in consideration of the premises, divers other good and sufficient reasons me thereunto moving, do hereby commute the aforesaid total prison sentence of the said **ANTONIO GUERRERO** to expire on December 17, 2014, commuting also the term of supervised release in its entirety and remitting any unpaid balance of the special assessment, upon the following conditions:

- (1) the said **ANTONIO GUERRERO** shall depart the United States on December 17, 2014;
- (2) the said **ANTONIO GUERRERO** shall, within two weeks of December 17, 2014, appear at the U.S. Interests Section in Havana, Cuba, and voluntarily renounce his U.S. citizenship;
- (3) the said **ANTONIO GUERRERO** shall, following renunciation of his U.S. citizenship, remain outside the limits of the United States, its territories, and its possessions;
- (4) the said **ANTONIO GUERRERO** shall not accept or otherwise receive any financial benefit, directly or indirectly, in any manner or amount, from any book, movie, or other publication or production, in any form or media, about his situation;
- (5) the said **ANTONIO GUERRERO** shall renounce any claim to benefits, including benefits under the Old Age, Survivors, and Disability Insurance Program, related to employment while in the United States; and

(6) the said **ANTONIO GUERRERO** shall waive and release any and all claims, demands, rights, and causes of action of whatsoever kind and nature against the United States of America, its agents, servants, and employees, including any actions challenging his conviction or sentence.

If, at any time, the said **ANTONIO GUERRERO** violates any one or more of the aforesaid conditions, as determined by me in my complete discretion (or by a future President in his or her or complete discretion), this commutation may be voided in its entirety and, if the said **ANTONIO GUERRERO** shall be found at any time within the United States, its territories, or its possessions, he may be recommitted under the original judgment of conviction to a penal institution designated by the Attorney General and remain incarcerated until the sentence as originally imposed on him and subsequently modified by the court shall be served by him in accordance with law or until he is otherwise released in accordance with law.

No. 58739-004) was convicted in the United States District Court for the Southern District of Florida (Docket No. 1:98CR0721-001) on an indictment charging violations of Sections 794(c), 1117, and 1546(a) of Title 18, United States Code, for which a total effective sentence of life imprisonment, five years of supervised release, and a special assessment of \$1,200 was imposed on December 12, 2001; and

*WHEREAS* the said **GERARDO HERNANDEZ** has been continuously confined since September 12, 1998; and

*WHEREAS* it has been made to appear that the ends of justice, foreign policy considerations, and the national security of the United States require that the aforesaid sentence not be served in its entirety;

NOW, THEREFORE, BE IT KNOWN that I, BARACK OBAMA, President of the United States of America, pursuant to my powers under Article II, Section 2, clause 1, of the Constitution, and in consideration of the premises, divers other good and sufficient reasons me thereunto moving, do hereby commute the aforesaid total prison sentence of the said **GERARDO HERNANDEZ** to expire on December 17, 2014, commuting also the term of supervised release in its entirety and remitting any unpaid balance of the special assessment, upon the following conditions:

*WHEREAS* **LUIS MEDINA III, also known as RAMON LABANINO** (Reg. No. 58734-004), was convicted in the United States District Court for the Southern District of Florida (Docket No. 1:98CR0721-002) on an indictment charging violations of Sections 371, 794(c), 951, 1028(a)(3), 1542, and 1546(a) of Title 18, United States Code, for which a total effective sentence of life imprisonment, five years of supervised release, and a special assessment of \$950 was imposed on December 13, 2001; and

*WHEREAS*, following appeal, the said **LUIS MEDINA III, also known as RAMON LABANINO**, was resentenced on December 8, 2009, to a total effective sentence of 360 months of imprisonment, five years of supervised release, and a special assessment of \$950;

*WHEREAS* the said **LUIS MEDINA III, also known as RAMON LABANINO**, has been continuously confined since September 12, 1998; and

*WHEREAS* it has been made to appear that the ends of justice, foreign policy considerations, and the national security of the United States require that the aforesaid sentence not be served in its entirety;
