

Executive Grant of Clemency

TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

WHEREAS **ROMAN SELEZNEV, Reg. No. 04385-093**, was convicted in the United States District Court for the Northern District of Georgia on an indictment (Docket No. 1:09-cr-0491-SCJ-LTW-13) of a violation of Section 1349, Title 18, United States Code, for which a total sentence of 168 months' imprisonment, three years' supervised release, restitution in the amount of \$2,178,349.00, and a special assessment of \$100.00 was imposed on November 30, 2017; and

WHEREAS **ROMAN SELEZNEV, Reg. No. 04385-093**, was convicted in the United States District Court for the Northern District of Georgia on an indictment (Docket No. 1:17-cr-0306-SCJ-1, transferred from the District of Nevada, Docket No. 2:12-cr-0004-APG-GWF-14) of a violation of Section 1962(c), Title 18, United States Code, for which a total sentence of 168 months' imprisonment, three years' supervised release, restitution in the amount of \$50,893,166.35, and a special assessment of \$100.00 was imposed on November 30, 2017; and

WHEREAS **ROMAN SELEZNEV, Reg. No. 04385-093**, was convicted in the United States District Court for the Western District of Washington on an indictment (Docket No. 2:11-cr-0070-RAJ-1) of violations of Sections 1343, 1028A, 1029, and 1030, Title 18, United States Code, for which a total sentence of 324 months' imprisonment, restitution in the amount of \$169,919,973.25, and a special assessment of \$3,800 was imposed on April 21, 2017 (as amended June 15, 2018); and

WHEREAS the said **ROMAN SELEZNEV** has been confined continuously since his arrest on July 7, 2014; and

WHEREAS it has been made to appear that it is in the national interest that the terms of imprisonment related to the aforesaid convictions not be served in their entirety:

NOW, THEREFORE, BE IT KNOWN that I, **JOSEPH R. BIDEN, JR.**, President of the United States of America, pursuant to my powers under Article II, Section 2, clause 1 of the Constitution, in consideration of the premises, divers other good and sufficient reasons me thereunto moving, do hereby commute the aforesaid total prison sentences of the said **ROMAN SELEZNEV** to time served, leaving intact any unpaid balance of the restitutions and special assessments, upon the following conditions:

- (1) the said **ROMAN SELEZNEV** shall depart the United States;
- (2) the said **ROMAN SELEZNEV** shall remain outside the limits of the United States, its territories, and its possessions;
- (3) the said **ROMAN SELEZNEV** shall not commit any additional crime against the United States or in violation of the laws of the United States subsequent to the acceptance of this Commutation;

- (4) the said **ROMAN SELEZNEV** shall waive any and all claims to funds or property already seized or subject to forfeiture as part of the prosecution of offenses subject to this Commutation;
- (5) the said **ROMAN SELEZNEV** shall not accept or otherwise receive any financial benefit, directly or indirectly, in any manner or amount, from any book, movie, or other publication or production, in any form or media, about the circumstances surrounding the instant offenses or Commutation; and
- (6) the said **ROMAN SELEZNEV** shall waive and release any and all claims, demands, rights, and causes of action of whatsoever kind and nature against the United States of America, its agents, servants, and employees, including any actions challenging his convictions or sentences.

IF AT ANY TIME the said **ROMAN SELEZNEV** violates any one or more of the aforesaid conditions, as determined by me in my complete discretion (or by a future President in his or her complete discretion), this Commutation may be voided in its entirety and all terms of the originally imposed sentences reinstated.

THIS GRANT SHALL BECOME EFFECTIVE only upon the delivery and presentment of a certified copy of this document, electronic or hard copy, to the said **ROMAN SELEZNEV** and upon the said **ROMAN SELEZNEV**'S signing of a receipt verifying his acceptance of the Commutation granted with all of its terms and conditions.

I HEREBY DESIGNATE that a certified copy of this document be delivered by a designee of the Attorney General to Immigration and Customs Enforcement, the Bureau of Prisons, the United States District Court for the Northern District of Georgia and the United States District Court for the Western District of Washington, other appropriate law enforcement entities, and the said **ROMAN SELEZNEV** as evidence of my action in order to carry into effect the terms of this grant.

IN TESTIMONY WHEREOF, I have hereunto signed my name and caused the Commutation to be recorded with the Department of Justice.
