Dear Disability Community Members and Leaders:

The Antitrust Division of the U.S. Department of Justice has a critical mission to support a vibrant and competitive American economy, and the Division recognizes that a richly diverse staff makes better decisions in furtherance of its mission.

Therefore, we seek a workforce composed of a wide cross section of America. In support of this goal, I hope all members of the disability community will consider applying for positions with the Antitrust Division. I also ask for your assistance in alerting individuals you may know in the disability community about possible employment opportunities at the Antitrust Division.

The Antitrust Division is actively seeking application by all qualified persons who voluntarily selfidentify as disabled and who wish to join the Division. An Executive Order, signed by President Barack Obama on July 26, 2010, renews the commitment of the Federal Government to hire 100,000 persons with disabilities into the Executive Branch over the next five years. Attorney General Eric Holder also has committed to increase the diversity of the Department's career civil service workforce.

To support the Federal Government's efforts to enhance the diversity and full inclusion of persons with disabilities (among others) in the federal workforce, the U.S. Office of Personnel Management has promulgated Schedule A hiring authority. This authority provides an additional Federal recruitment process for attorneys and non-attorneys with disabilities, who meet the requirements of 5 CFR 213.3102(u) and who initiate voluntary self-identification of disability, to be appointed to career positions with the Antitrust Division and within the overall Federal government. Employment Opportunity Resources

 To assist in the hiring of individuals with disabilities under the Schedule A hiring process, the Antitrust Division has an <u>on-line job bank (</u> <u>http://www.justice.gov/atr/contact/258645.pdf</u>) into which qualified individuals may submit their resume for use in filling Division job vacancies. These resumes are kept active for up to one year.

Those seeking to work for the Division either as employees or interns also are encouraged to inform the Attorney General's Committee on the Employment of Persons with Disabilities in order to secure additional assistance in moving through the selection process and to help ensure that candidates are supported in their efforts to join the Department.
