## Electronic Submission Becomes Mandatory

DAG-71 Sharing Requests are now required to be submitted electronically through the eShare Portal effective March 31, 2015. Paper versions of this form will no longer be accepted. The eShare Portal is a web-based tool that allows agencies to submit and track sharing requests and run sharing distribution reports. Every agency in the Equitable Sharing Program has received a notice with instructions detailing how to obtain accounts.

If your agency has not yet obtained eShare Portal accounts, the finance contact should email or call the eShare helpdesk at [forfeiture.systems@usdoj.gov](mailto:forfeiture.systems@usdoj.gov) or (202) 616-2287 to obtain the necessary forms.

## Reminder: DAG-71 Submission Deadline has Changed

As previously announced in the August 11, 2014, *Equitable Sharing Wire*, the deadline for submitting DAG-71 Sharing Requests is 45 days following the date of forfeiture. This policy applies to ALL state, local, and federal law enforcement agencies participating in the DOJ Equitable Sharing Program. A waiver request for a late submission is required ONLY if the request is filed after 45 days following forfeiture. The DAG-71 can be completed any time following seizure in the eShare Portal. However, it is recommended that the DAG-71 not be submitted until all workhours and contributions are captured in the narrative. The system will send an eNote to the agency after an asset is forfeited advising that the sharing request should be submitted. If an agency attempts to submit a DAG-71 after 45 days after forfeiture, the eShare Portal will advise the agency that a late waiver is required.
