

## OREGON

24. **Immanuel Free Methodist Church (Portland)** - On June 20, 1996, this inter-racial church was burned. Antoine **Jamar Dean**, 21, pled guilty in federal court to one count of 18 U.S.C. §844(i). He received a five-year sentence.

## SOUTH CAROLINA

25. **Life Christian Assembly (North Charleston)** - On June 17, 1996, this inter-racial church was burned. Two juveniles, ages 9 and 10, were convicted and sentenced in state court to house arrest and restitution.

26. **Mount Zion A.M.E. Church (Greeleyville)**

27. **Macedonia Baptist Church (Manning)** - On June 20 and 21, 1995, respectively, these two African-American churches were burned. The following four ex-members of the Ku Klux Klan pled guilty to federal charges relating to these arsons: Gary Cox, 23, Timothy Welch, 24, Arthur Haley, 51, and Hubert Rowell, 50. Sentencing is pending.

28. **Rice Chapel (Buffalo)** - On May 8, 1994, this African-American church was burned. In August, 1995, James Isaac Mitchell, a 22-year-old volunteer fire fighter, pled guilty to state charges and received a 10-year sentence.

29. **Hammond Grove Baptist Church (North Augusta)** - On March 8, 1995, this African-American church was vandalized. Two juveniles, ages 14 and 16, were convicted and sentenced to six-months' probation and restitution.

## TENNESSEE

30. **Canaan A.M.E. Church (Maury County) (Middle District)**

31. **Friendship Missionary Baptist Church (Maury County) (Middle District)** - Mark Jett, 33, Michael Jett, 43, and Robert Johnson, 35, all Caucasian men, pled guilty in federal court to conspiring to firebomb and either burn or erect crosses at these two African-American churches in February, 1995. One defendant was sentenced to 57 months in prison while the two other defendants were sentenced to 46 months in prison.

32. **Church of the Nativity (Bartlett) (Western District)** - On June 29, 1996, this Roman Catholic church was burned. It had a predominantly Caucasian congregation. Father Frederick Sauer, 46, pled guilty in federal court to one count of 18 U.S.C. §844 (i). Sentencing is pending.
