## **Executive Office for Immigration Review Recently Swears in Seven Immigration Judges**

FALLS CHURCH, VA – The Executive Office for Immigration Review (EOIR) announces the recent investiture of seven new immigration judges. Lafuente-Gaona, and Dinesh C. Verma to their new positions.

### **Marcos Gemoets, Immigration Judge, Houston Immigration Court**

Attorney General Jeff Sessions appointed Marcos Gemoets to begin hearing cases in September 2017. Judge Gemoets earned a Bachelor of Science degree in 1999 from Georgetown University and a Juris Doctor in 2002 from St. Mary's School of Law.
