**INDICTMENT**

THE GRAND JURY CHARGES THAT:

**COUNT 1**

Beginning in or about June 2011, and continuing through on or about June 3, 2013, in the Eastern District of Arkansas and elsewhere,

JEREMY J. BURTON  
MICHAEL ALLEN YOUNG  
BRIAN WILLARD FLETCHER  
JASON MATTHEW HOBBY  
HEATHER MARIE GOODEN  
STEPHANIE ANN MARIE HAGIE  
FRANKI SUE DRENNAN

knowingly and intentionally conspired with each other and other persons known and unknown to the grand jury to knowingly and intentionally possess with intent to distribute and to distribute a Schedule II controlled substance, to wit: Hydromorphone, Oxycodone and Oxymorphone, thereby violating Title 21, United States Code, sections 841(a)(1), (b)(1)(C) and 846.

COUNT 2

On or about June 15, 2012, in the Eastern District of Arkansas,

HEATHER MARIE GOODEN

knowingly and intentionally possessed with intent to distribute and distributed Oxycodone, a Schedule II controlled substance, thereby violating Title 21, United States Code, sections 841(a)(1) and (b)(1)(C).

COUNT 3

On or about June 19, 2012, in the Eastern District of Arkansas,

HEATHER MARIE GOODEN

knowingly and intentionally possessed with intent to distribute and distributed Hydromorphone, a Schedule II controlled substance, thereby violating Title 21, United States Code, sections 841(a)(1) and (b)(1)(C).

COUNT 4

On or about November 20, 2012, in the Eastern District of Arkansas,

BRIAN WILLARD FLETCHER

knowingly and intentionally possessed with intent to distribute and distributed Oxycodone, a Schedule II controlled substance, thereby violating Title 21, United States Code, sections 841(a)(1) and (b)(1)(C).

COUNT 5

On or about November 30, 2012, in the Eastern District of Arkansas,

JASON MATTHEW HOBBY

knowingly and intentionally possessed with intent to distribute and distributed Oxycodone, a

Schedule II controlled substance, thereby violating Title 21, United States Code, sections 841(a)(1) and (b)(1)(C).

COUNT 6

On or about December 12, 2012, in the Eastern District of Arkansas,

JEREMY J. BURTON

knowingly and intentionally possessed with intent to distribute and distributed Oxymorphone, a Schedule II controlled substance, thereby violating Title 21, United States Code, sections 841(a)(1) and (b)(1)(C).

COUNT 7

On or about March 18, 2013, in the Eastern District of Arkansas,

FRANKI SUE DRENNAN

knowingly and intentionally possessed with intent to distribute and distributed Oxymorphone, a Schedule II controlled substance, thereby violating Title 21, United States Code, sections 841(a)(1) and (b)(1)(C).
