FACTUAL BASIS

Should this matter proceed to trial, both the government and the defendant, **CHRISTOPHER JAMIESON** ("**JAMIESON**") do hereby stipulate and agree that the following facts set forth a sufficient factual basis for the crime to which the defendant is pleading guilty and that the government would prove the following beyond a reasonable doubt at trial:

On or about May 15, 2013, Special Agents with the U.S. Department of Homeland Security, Homeland Security Investigations ("**HSI**") and the United States Postal Inspection Service ("**USPIS**") executed a federal search warrant at the Abita Springs, Louisiana residence of Jonathan Johnson. The investigation revealed that Jonathan Johnson enticed numerous minors,

between the ages of 13 and 17 to engage in sexually explicit conduct on the Internet, either alone, with other children as young as 18 months old, and with animals. Johnson recorded the sexually explicit activity and traded the material with individuals on the Internet. Johnson also uploaded the sexually explicit content involving minors to two websites which were created by Johnson: Website A and Website B. These two websites specialized in material involving the sexual exploitation of minors.

Johnson would testify that he communicated with individuals, including the defendant, involved with Website A and Website B using various computer related communication methods, including Skype, Facebook, email, internet relay chat, Team Speak, GigaTribe, etc. Johnson and the other users of Websites A and B created fictitious female personas on Internet social networking sites in order to locate and entice minors to engage in sexually explicit activity for the purpose of recording the activity and for further distribution.

A computer forensic search of Johnson's computer related media and online social network accounts revealed that Johnson communicated on the Internet with **JAMIESON**. The government would establish that beginning on or about April 27, 2013, **JAMIESON** began communicating with Johnson about trading videos depicting the sexual victimization of children. Several sexually explicit videos depicting the sexual exploitation of minors were transferred between Johnson and **JAMIESON**. Below are descriptions of some of the files received by **JAMIESON** from Johnson.

Description: 50 minute and 43 second long video that depicted
what appeared to be a 13 year old male and an 11 year old female.
During the video, the male displayed his penis and licked the
female child's breast nipples. The female then manually
stimulated the male's penis. The male then continued to

masturbate as the female watched.

Video: [Name Redacted]_myyb - 12yo pair [Name Redacted] and [Name Redacted] jerk,fake suck, fuck (no cum, no snd).avi

Description: 27 minute and 29 second long video that depicted what appeared to be two 12 year old males who displayed their penises and masturbated. The two also performed oral sex on each other's penises. The two also appeared to attempt to have anal intercourse.

Video: [Name Redacted]_skype - 12yo [Name Redacted] and [Name Redacted] both have some fun together, fuck a bit.avi

Description: 42 minute and 4 second long video that depicted what appeared to be two 12 year old males who displayed their penises, masturbated and appeared to have anal intercourse.

Description: 19 minute and 25 second long video that depicts what appeared to be two males, under the age of eighteen, who displayed their penises and masturbated.

Description: 12 minute and 28 long video that depicted what appeared to be a 16 year old and 12 year old male who displayed their penises and masturbated.

HSI agents would introduce evidence that Johnson and **JAMIESON** exchanged approximately 500 sexually explicit videos from May 10, 2013 through May 13, 2013. File transfers sent by Johnson had video titles similar to the ones mentioned above.

The government would further establish that on November 5, 2013, a federal search warrant, based on probable cause, was executed by federal agents at **JAMIESON's** residence located in Douglasville, Georgia. **JAMIESON** was identified as an occupant of the residence. After being advised of his *Miranda* rights, **JAMIESON** admitted to receiving child pornography

from Johnson.

The government would establish through the testimony of computer forensic examiners and others, including Jonathan Johnson, that sexually explicit videos were traceable to **JAMIESON** and Johnson and that these videos were transported via computer to and from Johnson's residence located in the Eastern District of Louisiana. The government would establish, through the introduction of sexually explicit videos of children and online communications between Johnson and **JAMIESON**, that **JAMIESON** received from Johnson sexually explicit videos. The government would present testimony and records from Internet service providers to further corroborate the illegal transfer of sexually explicit material involving minors between **JAMIESON** and Jonathan Johnson.

Further, the government would present evidence to establish that the videos of child pornography were created using phones, cameras, and/or and computer equipment that had been transported in interstate and foreign commerce. The government would show through testimony and documentary evidence that the equipment (phones, cameras, and/or computers) used by **JAMIESON** to receive the child pornography were all manufactured outside of the State of Louisiana and were transported in interstate or foreign commerce.


Forensic evidence consisting of medical testimony, law enforcement officers, and supporting documentation would establish that all of the videos exchanged between **JAMIESON** and Johnson were of pubescent children less than 18 years of age, some of the videos depicted prepubescent children less than twelve (12) years of age, and that the videos of the child victims were "sexually explicit" as defined in Title 18, United States Code, Section 2256. None of the videos received by **JAMIESON** depict acts of violence or sadomasochistic abuse nor does it appear that **JAMIESON** distributed child pornography to minors. All of the

videos depicting the sexual victimization of minors exchanged between JAMIESON and Johnson would be introduced through the testimony of HSI and other agents.

Various records and testimonial evidence, including testimony from representatives of HSI and the USPIS, as well as other witnesses, would also be called to prove the facts set forth above.


LIMITED NATURE OF FACTUAL BASIS


