COUNT 1

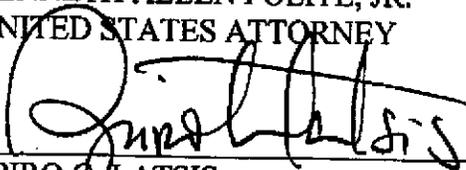
