COUNT 1

On or about August 20, 2014, in the Eastern District of Louisiana, the defendant, **RONY RIVERA-GONZALES, a/k/a LUIS TORRES RIVERA, (RIVERA-GONZALES)** in a matter within the jurisdiction of the Social Security Administration, for the purpose of obtaining something of value and for other purposes, to wit: to obtain a Louisiana identification card, knowingly and with intent to deceive, did falsely represent that Social Security Number XXX-XX-4825 was assigned to him by the Commissioner of Social Security when, in fact, as defendant well knew, said Social Security Number had not been assigned to him by the


