**INDICTMENT**

**COUNTS ONE - TEN**

**THE GRAND JURY CHARGES THAT:**

On or about the dates set forth below (each date constituting a separate count of the Indictment), in Yardley, in the Eastern District of Pennsylvania, defendant

**THOMAS SILBER**

knowingly received, and attempted to receive, visual depictions, that is, the DVD movies listed below, using a facility of interstate and foreign commerce, and which DVD movies had been shipped and transported in and affecting interstate and foreign commerce, and contained materials that had been shipped and transported in and affecting interstate and foreign commerce. The producing of these visual depictions involved the use of minors engaging in sexually explicit conduct, and such visual depictions were of minors engaging in sexually explicit conduct, to wit:

**NOTICE OF FORFEITURE**

1. As a result of the violations of Title 18, United States Code, Sections 2252(a)(2) and 2254(a)(4)(B), set forth in this indictment, the defendant,

**THOMAS SILBER,**

shall forfeit to the United States, pursuant to Title 18, United States Code, Sections 2253(a)(1) and(a)(3), all visual depictions described in Title 18, United States Code Section 2252, and all property, real or personal, used or intended to be used to commit or promote the commission of the offenses of conviction, including but not limited to the following items that were seized from defendant on September 12, 2013:

- a. 71 DVD recordings distributed by Azov films.
