INDICTMENT

COUNT ONE

THE GRAND JURY CHARGES THAT:

1. At all times relevant to the indictment, H&Y Royal Jewelers, 2437 South 23rd Street, Philadelphia, Pennsylvania (“H&Y Jewelers”), was a business engaged in interstate commerce buying and selling jewelry transported from other states to the Commonwealth of Pennsylvania.

2. On or about December 27, 2013, in the Eastern District of Pennsylvania, defendants

JIBRI CUNNINGHAM,
a/k/a “Bri,”
TAJELDIN CUNNINGHAM,
a/k/a “Taj,”
SAMAR TAYLOR,
a/k/a “Mar,”
a/k/a “Mar Mar,” and

**LAVELL CARTER,
a/k/a “Vell,”
a/k/a “Velly”**

and others known and unknown to the grand jury, obstructed, delayed, and affected commerce and the movement of articles and commodities in commerce, by robbery, in that defendants JIBRI CUNNINGHAM, TAJELDIN CUNNINGHAM, SAMAR TAYLOR, and LAVELL CARTER unlawfully took and obtained, and aided and abetted the unlawful taking and obtaining of, United States currency from H&Y Jewelers, in the presence the owner and employees of H&Y Jewelers, and against their will by means of actual and threatened force, violence, and fear of injury, immediate and future, to the owners and employees, that is, by brandishing a gun at, and otherwise threatening the owner and employees.

In violation of Title 18, United States Code, Sections 1951(a) and 2.

COUNT TWO

THE GRAND JURY FURTHER CHARGES THAT:

On or about December 27, 2013, in the Eastern District of Pennsylvania,
defendants

**JIBRI CUNNINGHAM,
a/k/a "Bri,"
TAJELDIN CUNNINGHAM,
a/k/a "Taj,"
SAMAR TAYLOR,
a/k/a "Mar,"
a/k/a "Mar Mar," and
LAVELL CARTER,
a/k/a "Vell,"
a/k/a "Velly"**

knowingly used and carried, and aided and abetted the use and carrying of, a firearm, that is, a Glock .9mm handgun, serial number FCB-208US, and a Taurus .9mm handgun, serial number TCN-861000, during and in relation to a crime of violence for which they may be prosecuted in a Court of the United States, that is, robbery which interferes with interstate commerce, in violation of Title 18, United States Code, Sections 1951(a) and 2, and brandished, and aided and abetted the brandishing of, that firearm.

In violation of Title 18, United States Code, Sections 924(c)(1) and 2.
