

Thanks for arranging that call today with Resivour. It sounds like it may bear fruit. I have a 52mm dollar deal as I said that if I do it, I have till late tomorrow to commit and wire money. I have 15mm and need 37. If you know a source, the importance of this deal is each week I will get another inventory, the goods will be sold initially to ubid and then sold off to 2-3 AAA Credit retailers. Ubid as the face only.

The gross profit on the deal is approx. 27mm. I can do the transaction in 90 days start to finish. Thus could finish and pay out max 115 days each week another inventory for another 3 months I will get a premium inventory from this source. Not doing it this week it will go to my competitor in California. There will be other deals if I don't do this. Its really a lucrative one.

My value proposition is if you have source for this and possibly some of the others which I wi share in the funding each week I will split 1/3 profit with you less money costs? This could lead to traction and us building a nice nest egg over next 3 months, this is sony merchandise, moving from what was to be CC and they won't ship... Give me your thoughts, Tom
