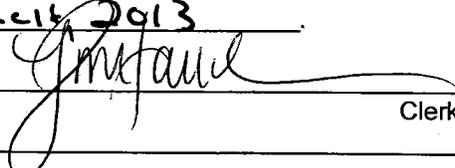

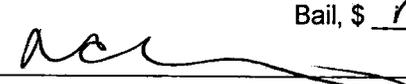

22 COUNT ONE: (21 U.S.C. § 841(a)(1) and (b)(1)(C) – Possession With Intent to
Distribute and Distribution of Cocaine Base in the Form of “Crack”)

24 On or about November 5, 2012, in the Northern District of California, the defendant,

25 ADELL BURRELL,

26 did knowingly and intentionally possess with intent to distribute and distribute a Schedule II
27 controlled substance, to wit: a mixture and substance containing cocaine base in the form of
28 “crack,” in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

INDICTMENT

1 COUNT TWO: (21 U.S.C. § 860(a) – Possession with Intent to Distribute and Distribution
2 of Cocaine Base in the Form of “Crack” Within 1,000 Feet of a School)

3 On or about November 5, 2012, in the Northern District of California, the defendant,

4 ADELL BURRELL,

5 did knowingly and intentionally possess with intent to distribute and distribute a Schedule II
6 controlled substance, to wit: a mixture and substance containing cocaine base in the form of
7 “crack,” within 1,000 feet of the real property comprising the St. Andrews Missionary Baptist
8 Church, Private School, and Kindergarten, in violation of Title 21, United States Code, Sections
9 841(a)(1) and 860(a).

10
11 DRUG FORFEITURE ALLEGATION (21 U.S.C. § 853 – Drug Forfeiture)

12 The factual allegations contained in Counts One and Two of this Indictment are realleged
13 and by this reference fully incorporated herein for the purpose of alleging forfeiture pursuant to
14 the provisions of 21 U.S.C. §§ 853(a)(1) and (a)(2).

15 Upon a conviction of any of the offenses alleged in Counts One and Two, the defendant,

16 ADELL BURRELL,

17 shall forfeit to the United States all right, title, and interest in property constituting and derived
18 from any proceeds the defendant obtained, directly or indirectly, as a result of said violations, and
19 any property used, or intended to be used, in any manner or part, to commit or to facilitate the
20 commission of the said violations.

21 If, as a result of any act or omission of the defendant, any of said property:

- 22 a. cannot be located upon the exercise of due diligence;
- 23 b. has been transferred or sold to or deposited with, a third person;
- 24 c. has been placed beyond the jurisdiction of the Court;
- 25 d. has been substantially diminished in value; or
- 26 e. has been commingled with other property which cannot be divided without
27 difficulty;

28 any and all interest the defendant has in any other property (not to exceed the value of the above

1 forfeitable property) shall be vested in the United States and forfeited to the United States.

2 All in violation of Title 21, United States Code, Section 853(a)(1), (a)(2), (p) and Rule
3 32.2 of the Federal Rules of Criminal Procedure.

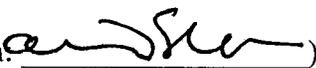

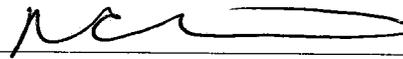
