The United States Attorney charges:

COUNT ONE: 18 U.S.C. § 2252(a)(4)(B) - Possession of Child Pornography

On or about April 10, 2013, in the District of Oregon, the defendant,

JOHN WILLIAM HARRISON,

did knowingly possess at least one matter which contained a visual depiction that had been
mailed, shipped and transported in and affecting interstate and foreign commerce, and which was
produced using materials which have been mailed, shipped and transported in interstate and
foreign commerce, by any means including by computer, the production of such visual depiction
having involved the use of a minor engaging in sexually explicit conduct, and such depiction was
of such conduct; in violation of Title 18, United States Code, Section 2252(a)(4)(B).

1 COUNT TWO: 18 U.S.C. § 2252(a)(2) - Distribution of Child Pornography

2 On or about April 12, 2013, in the Northern District of California, the defendant,
3 JOHN WILLIAM HARRISON,
4 did knowingly distribute at least one visual depiction that had been mailed and shipped and
5 transported in and affecting interstate and foreign commerce, and which contains materials which
6 had been so mailed and shipped and transported by any means, including by computer, the
7 production of which involved the use of a minor engaging in sexually explicit conduct and which
8 visual depiction was of such conduct, in violation of Title 18, United States Code, Section
9 2252(a)(2).


