21 COUNT ONE: (18 U.S.C. § 2252(a)(4)(B) - Possession of Child Pornography)

22 On or about July 20, 2011, in the Northern District of California, the defendant,

23 JESSE YANG,

24 did knowingly possess at least one matter which contained visual depictions that had been
25 mailed, shipped, and transported in and affecting interstate and foreign commerce, and which
26 were produced using materials which have been mailed, shipped, and transported in interstate
27 and foreign commerce, by any means including by computer, the production of such visual
28 depictions having involved the use of a minor engaging in sexually explicit conduct, and such

1 depictions were of such conduct, in violation of Title 18, United States Code, Section
2 2252(a)(4)(B).

3 FORFEITURE ALLEGATION: (18 U.S.C. §§ 2253(a)(1) and (a)(3) - Criminal Forfeiture)

4 Upon conviction of either of the offenses alleged in Count One, the defendant,



6 shall forfeit to the United States, pursuant to Title 18, United States Code, Sections 2253(a)(1)
7 and (a)(3), all visual depictions described in Title 18, United States Code, Section 2252, and all
8 property, real or personal, used or intended to be used to commit or promote the commission of
9 the offenses of conviction, including but not limited to the following item that was seized from
10 the defendant on July 20, 2011:

- 11 1. A custom-built black and red desktop computer labeled "thermaltake."

12 In violation of Title 18, United States Code, Sections 2253(a)(1) and (a)(3).
