



19 The Grand Jury charges:

20 COUNT ONE: (18 U.S.C. § 2252(a)(2) – Distribution of Child Pornography)

21 On or about November 11, 2012, in the Northern District of California, the defendant,

22 TERRY HOWELL,

23 did knowingly distribute at least one visual depiction that had been mailed and shipped and transported  
24 in or affecting interstate or foreign commerce, and which contains materials which had been so mailed  
25 and shipped and transported by any means including by computer, the production of such visual  
26 depiction involved the use of a minor engaging in sexually explicit conduct and the visual depiction is of  
27 such conduct, in violation of Title 18, United States Code, Section 2252(a)(2).

INDICTMENT

1 COUNT TWO: (18 U.S.C. § 2252(a)(2) – Receipt of Child Pornography)

2 From on or about October 14, 2012, through on or about November 11, 2012, in the Northern  
3 District of California, the defendant,

4 TERRY HOWELL,

5 did knowingly receive any visual depiction using any means or facility of interstate or foreign commerce  
6 and that has been shipped and transported in or affecting interstate or foreign commerce, by any means,  
7 including by computer, where the production of such visual depiction involved the use of a minor  
8 engaging in sexually explicit conduct, and such visual depiction was of such conduct, in violation of  
9 Title 18, United States Code, Section 2252(a)(2).

10  
11 COUNT THREE: (18 U.S.C. § 2252(a)(4)(B) - Possession of Child Pornography)

12 From on or about January 20, 2013, to on or about March 28, 2013, in the Northern District of  
13 California, the defendant,

14 TERRY HOWELL,

15 did knowingly possess, and access with intent to view, at least one matter which contained visual  
16 depictions that had been mailed, shipped, and transported in and affecting interstate and foreign  
17 commerce, and which were produced using materials which have been mailed, shipped, and transported  
18 in interstate and foreign commerce, by any means including by computer, the production of such visual  
19 depictions having involved the use of a prepubescent minor and a minor who had not attained 12 years  
20 of age engaging in sexually explicit conduct, and such depictions were of such conduct, in violation of  
21 Title 18, United States Code, Section 2252(a)(4)(B).

1 FORFEITURE ALLEGATION: (18 U.S.C. §§ 2253(a)(1) and (a)(3) - Criminal Forfeiture)

2 Upon conviction of any of the offenses alleged in Counts One, Two, and Three, the defendant,

4 shall forfeit to the United States, pursuant to Title 18, United States Code, Sections 2253(a)(1) and  
5 (a)(3), all visual depictions described in Title 18, United States Code, Section 2252, and all property,  
6 real or personal, used or intended to be used to commit or promote the commission of the offenses of  
7 conviction, including but not limited to the following item:

8 A LG-MS690 cellular telephone, MSISDN 5109781414;


9 All in violation of Title 18, United States Code, Sections 2253(a)(1) and (a)(3).




