



2 production of which involved the use of a minor engaging in sexually explicit conduct and which
3 visual depiction was of such conduct, in violation of Title 18, United States Code, Section
4 2252(a)(2).

5 COUNT TWO: (18 U.S.C. § 2252(a)(4)(B) - Possession of Child Pornography)

6 On or about February 4, 2013, in the Northern District of California, the defendant,

11 did knowingly possess at least one matter which contained visual depictions that had been
12 mailed, shipped, and transported in and affecting interstate and foreign commerce, and which
13 were produced using materials which have been mailed, shipped, and transported in interstate
14 and foreign commerce, by any means including by computer, the production of such visual
15 depictions having involved the use of a minor engaging in sexually explicit conduct, and such
16 depictions were of such conduct, in violation of Title 18, United States Code, Section
17 2252(a)(4)(B).

18 FORFEITURE ALLEGATION: (18 U.S.C. §§ 2253(a)(1) and (a)(3) - Criminal Forfeiture)

19 Upon conviction of either of the offenses alleged in Count One and Count Two, the
20 defendant,

25 shall forfeit to the United States, pursuant to Title 18, United States Code, Sections 2253(a)(1)

28 the offenses of conviction, including but not limited to the following items that was seized from
the defendant on February 4, 2013:




