The SPECIAL JULY 2013 GRAND JURY further charges:

On or about June 5, 2014, at Gardner, in the Northern District of Illinois,  
Eastern Division,

PATRICK SEAN KEIRAN,

defendant herein, being a federally licensed firearms dealer, did willfully sell and deliver a firearm, namely, a .38 caliber Charter Arms revolver, Model: Undercover-Lite, bearing serial number 13-35462, without noting in records required to be kept pursuant to Title 18, United States Code, Section 923, the name, age and place of residence of the purchaser of said firearm;

In violation of Title 18, United States Code, Sections 922(b)(5) and 924(a)(1)(D).

**COUNT THREE**

The SPECIAL JULY 2013 GRAND JURY further charges:

On or about June 12, 2014, at Elwood, in the Northern District of Illinois,  
Eastern Division,

PATRICK SEAN KEIRAN,

defendant herein, being a federally licensed firearms dealer, did willfully sell and  
deliver a firearm, namely:

(1) American Tactical Imports .22 caliber rifle, Model: Omni, bearing serial  
number AR45669; and

(2) Mossberg .22 caliber rifle, Model: 715T, bearing serial number  
EMG3829974;

without noting in records required to be kept pursuant to Title 18, United States  
Code, Section 923, the name, age and place of residence of the purchaser of said  
firearm;

In violation of Title 18, United States Code, Sections 922(b)(5) and  
924(a)(1)(D).

**COUNT FOUR**

The SPECIAL JULY 2013 GRAND JURY further charges:

On or about June 20, 2014, at Elwood, in the Northern District of Illinois,  
Eastern Division,

PATRICK SEAN KEIRAN,

defendant herein, being a federally licensed firearms dealer, did willfully sell and deliver a firearm, namely:

- (1) SCCY, Model: CPX-2, 9mm, bearing serial number: 145751;
- (2) SCCY, Model: CPX-2, 9mm, bearing serial number: 145752;
- (3) SCCY, Model: CPX-2, 9mm, bearing serial number: 145753;
- (4) SCCY, Model: CPX-2, 9mm, bearing serial number: 145754; and
- (5) SCCY, Model: CPX-2, 9mm, bearing serial number: 145755;

without noting in records required to be kept pursuant to Title 18, United States Code, Section 923, the name, age and place of residence of the purchaser of said firearm;

In violation of Title 18, United States Code, Sections 922(b)(5) and 924(a)(1)(D).

**COUNT FIVE**

The SPECIAL JULY 2013 GRAND JURY further charges:

On or about June 20, 2014, at Elwood, in the Northern District of Illinois,  
Eastern Division,

PATRICK SEAN KEIRAN,

defendant herein, being a federally licensed firearms dealer, did willfully sell and deliver a firearm, namely:

- (1) SCCY, Model: CPX-2, 9mm, bearing serial number: 145751;
- (2) SCCY, Model: CPX-2, 9mm, bearing serial number: 145752;
- (3) SCCY, Model: CPX-2, 9mm, bearing serial number: 145753;
- (4) SCCY, Model: CPX-2, 9mm, bearing serial number: 145754; and
- (5) SCCY, Model: CPX-2, 9mm, bearing serial number: 145755;

to an individual in the State of Illinois, where the purchase and possession of such firearm was in violation of the laws of the State of Illinois, namely, Chapter 720, Illinois Compiled Statutes, Section 5/24-3(A)(k), which made it illegal to knowingly sell or transfer a firearm to a person who does not display to the seller a currently valid Firearm Owner's Identification Card;

In violation of Title 18, United States Code, Section 922(b)(2) and 924(a)(1)(D).

**COUNT SIX**

The SPECIAL JULY 2013 GRAND JURY further charges:

On or about June 20, 2014, at Elwood, in the Northern District of Illinois,  
Eastern Division,

PATRICK SEAN KEIRAN,

defendant herein, knowingly sold and disposed of a firearm, namely:

- (1) SCCY, Model: CPX-2, 9mm, bearing serial number: 145751;
- (2) SCCY, Model: CPX-2, 9mm, bearing serial number: 145752;
- (3) SCCY, Model: CPX-2, 9mm, bearing serial number: 145753;
- (4) SCCY, Model: CPX-2, 9mm, bearing serial number: 145754; and
- (5) SCCY, Model: CPX-2, 9mm, bearing serial number: 145755;

to an individual, knowing and having reasonable cause to believe that the individual had been convicted of a crime punishable by imprisonment for a term exceeding one year;

In violation of Title 18, United States Code, Sections 922(d)(1) and 924(a)(2).
