**COUNT ONE**

The SPECIAL JULY 2013 GRAND JURY charges:

Between in or around October 2010 and on or about July 18, 2011, in the Northern District of Illinois, Eastern Division, and elsewhere,

WALTER G. FREEMAN, aka "Charlie" and "Cha-Lay," and  
TIMOTHY VANA,

defendants herein, previously having been convicted of a crime punishable by a term of imprisonment exceeding one year, did knowingly possess in and affecting interstate commerce, a firearm, namely:

WALTER FREEMAN, aka “Charlie” and “Cha-Lay,”

defendant herein, not being a licensed dealer within the meaning of Chapter 44, Title 18, United States Code, did willfully engage in the business of dealing in firearms;

In violation of Title 18, United States Code, Section 922(a)(1)(A).
