ATTACHMENT A

On or about March 8, 2013, in Passaic County, in the District of New Jersey, and elsewhere, the defendant

ANTHONY CHIAMPI,

did knowingly possess material that contained at least three images of child pornography, as defined in Title 18, United States Code, Section 2256(8), which images were mailed, shipped, and transported using any means and facility of interstate and foreign commerce and in and affecting interstate and foreign commerce by any means, including by computer, and that were produced using materials that have been mailed, shipped, and transported in and affecting interstate and foreign commerce by any means, including by computer.

In violation of Title 18, United States Code, Section 2252A(a)(5)(B) and Section 2.

ATTACHMENT B

I, Michele R. Bolan, a Task Force Officer with the Federal Bureau of Investigation, have knowledge of the following facts based upon both my investigation and discussions with other law enforcement personnel and others. Because this affidavit is being submitted for the sole purpose of establishing probable cause to support the issuance of a complaint, I have not included each and every fact known to the government concerning this matter. Where statements of others are set forth herein, these statements are related in substance and in part. Where I assert that an event took place on a particular date, I am asserting that it took place on or about the date alleged.

1. Defendant ANTHONY CHIAMPI was convicted on July 10, 1996 in New Jersey Superior Court, Passaic County, for endangering the welfare of a child, and as a result, is a registered sex offender pursuant to Megan's Law. Because ANTHONY CHIAMPI is a Megan's Law registrant, he is on community supervision for life and subject to the special condition which precludes him from accessing the Internet, or from using any computers or devices.

2. On or about March 14, 2013, as part of his community supervision, officers of the New Jersey Division of Parole ("N.J. Parole") conducted a home visit at ANTHONY CHIAMPI's residence in Totowa, New Jersey. ANTHONY CHIAMPI permitted the officers to search his residence and signed a written consent to search form for his residence. N.J. Parole officers then discovered in ANTHONY CHIAMPI's residence approximately 63 disks containing child pornography, as defined in Title 18 United States Code, Section 2256(8). The disks consisted of over approximately 300 videos and 20,000 images of child pornography. The majority of the videos and images discovered were of prepubescent children.

3. Three of the 20,000 images located on the disks are described in detail below:

File Name: 1180211239428s.jpg	This image appears to depict a naked prepubescent female wearing only a silver necklace around her neck. The girl appears seated on a white blanket. The girl's hands are reaching out and grasping the penis of a naked adult male while she is licking the adult male's penis with her tongue. The image is cropped from the adult male's thigh to his lower chest area.
File Name: hh71105_1194739054346_123_76410.jpg	This image appears to depict a naked prepubescent girl lying on a bed or other piece of furniture, which appears to be covered in pink and a floral pattern satin. There is a naked adult male kneeling on top of

	<p>this young girl. The girl's right hand is reaching out and grasping the penis of the adult male. In the top left corner of the image are blue letters that read "Tri-Ropeck.". In the bottom right corner of this image are orange numbers that read "25.12.2001." The image is taken from the perspective of the male kneeling over and looking down upon the young girl.</p>
<p>File Name: hhh1199490212119.jpg</p>	<p>This image appears to depict a naked prepubescent girl lying on a bed or piece of furniture, which appears to be covered with a beige sheet and blanket. The young girl is positioned on her side with her buttocks and vagina exposed to the viewer of the image. This young girl's upper body is twisted which exposes her chest. The young girl is pushing a pink plastic object into her anus with her right hand. The girl has brown colored hair and is looking at the camera. The image is taken from the perspective of someone at the foot of the bed.</p>

4. ANTHONY CHIAMPI was read his Miranda rights, which he waived and therefore agreed to speak with the officers. ANTHONY CHIAMPI then admitted that he possessed disks containing child pornography.

5. Based upon my education, training and experience, and my discussions with other law enforcement officers, and to the best of my knowledge, the images described in paragraph 3 above traveled in interstate commerce and were produced using materials that were mailed and shipped and transported in and affecting interstate and foreign commerce, by any means, including by computer.
