I, Jeff Calandra, being duly sworn, state the following is true and correct to the best of my knowledge and belief. From in or about 2007 until in or about 2011, in Morris County, in the District of New Jersey, and elsewhere, defendant RONALD OSHRIN:

did knowingly distribute child pornography, as defined in Title 18, United States Code, Section 2256(8)(A), that has been mailed, and using any means and facility of interstate and foreign commerce shipped and transported in and affecting interstate and foreign commerce by any means, including by computer.

In violation of Title 18, United States Code, Section 2252A(a)(2)(A) and Title 18, United States Code, Section 2.

I further state that I am a Special Agent with the Federal Bureau of Investigation, and that this complaint is based on the following facts:

## ATTACHMENT A

1. I, Jeff Calandra, am a Special Agent with the Federal Bureau of Investigation ("FBI"). I am fully familiar with the facts set forth herein based on my own investigation, my conversations with other law enforcement officers, and my review of reports, documents, and items of evidence. Where statements of others are related herein, they are related in substance and part. Because this complaint is being submitted for a limited purpose, I have not set forth each and every fact that I know concerning this investigation. Where I assert that an event took place on a particular date, I am asserting that it took place on or about the date alleged.

2. In or about February of 2012, FBI agents learned of an IP address located in New Jersey that was posting photographs of clothed children on a known child pornography site with text statements indicating that the poster enjoyed masturbating to images of children and producing videos of pre-pubescent girls.

3. The IP Address returned to a specific residence in Budd Lake, Morris County, New Jersey, home of defendant RONALD OSHRIN.

4. On or about April 5, 2012, FBI agents spoke with OSHRIN at his home, where he voluntarily admitted in substance and in part to the following facts:

a. OSHRIN regularly downloads child pornography from various websites on the internet. He also regularly distributes child pornography through various methods including direct email and posting on known child pornography sites and file sharing sites.

b. OSHRIN has produced child pornography videos by the following method:

i. OSHRIN installed video cameras in several locations throughout his home, particularly in a bathroom and bedroom.

ii. When pre-pubescent girls were in the bathroom or bedroom, he would monitor the cameras and make video recordings of the girls as they were disrobing, using the shower or using the toilet.

iii. Because he installed multiple cameras in the bathroom, it allowed video production from various angles and allowed him to focus on specific areas of interest.

iv. In addition to recording the videos, OSHRIN produced "snapshot" or individual still photographs from the video

v. OSHRIN admitted to distributing, over the internet, the child pornography that he created for approximately five (5) years.

5. In addition to the aforementioned admissions, OSHRIN produced a portable hard disc drive which was encrypted. OSHRIN unencrypted the contents and voluntarily showed FBI agents one video of a pre-pubescent girl depicting her vagina and breasts.

6. After removing the hard drive from the home, agents also viewed the following items located on OSHRIN's hard drive:

She is visible from the waist down and her exposed vagina is the focus of the image. She is in a bathroom located inside defendant OSHRIN's residence. The image is taken from an approximately six (6) minute video depicting the female undressing and showering.
(b)	2.jpg	This image shows a naked pre-pubescent female approximately 12-15 years of age standing in front of what appears to be a hidden camera. Her vagina and breasts are exposed and are the focus of the image. She is in a bathroom located inside defendant OSHRIN's residence. The image is taken from an approximately two (2) minute video of the female undressing.
(c)	17.jpg	This image shows a naked pre-pubescent female with long brown hair, approximately 12-15 years of age, standing in front of a mirror. The image appears to be taken from a hidden camera located behind her. Her vagina and breasts are exposed. She is in a bathroom located inside defendant OSHRIN's residence. The image is taken from an approximately two (2) minute video of the female undressing.
