The defendant having waived in open court prosecution by indictment, the United States Attorney for the District of New Jersey charges:

COUNT ONE  
(Dealing in Firearms Without A License)

From in or about May 2012 to on or about August 15, 2012, in Camden County, in the District of New Jersey, and elsewhere, the defendant,

ERIC J. REED,

did knowingly and willfully engage in the business of dealing in firearms without a license by selling and transferring the following firearms:

1. Kel Tec PLR-16 .223 caliber pistol bearing an obliterated serial number (sold on or about July 23, 2012);
2. Smith and Wesson model SW9VE, 9 millimeter handgun, bearing an obliterated serial number (sold on or about July 25, 2012);
3. Ruger SR9C 9 millimeter handgun, bearing an obliterated serial number (sold on or about July 27, 2012);
4. Rossi M677 .357 caliber revolver bearing an obliterated serial number (sold on or about July 27, 2012);

5. Intratec AB-10 9 millimeter pistol, bearing an obliterated serial number (sold on or about July 30, 2012);
6. Glock Model 36, .45 caliber handgun bearing an obliterated serial number (sold on or about July 30, 2012);
7. Intratec AB-10 9 millimeter pistol, bearing an obliterated serial number (sold on or about July 31, 2012);
8. Ruger Model LC9 9 millimeter pistol, bearing an obliterated serial number (sold on or about July 31, 2012);
9. Glock Model 27, .40 caliber handgun bearing an obliterated serial number (sold on or about August 1, 2012);
10. Ruger Model SR40C .40 caliber handgun, bearing an obliterated serial number (sold on or about August 1, 2012);
11. Intratec TEC-DC9 9 millimeter pistol, bearing an obliterated serial number (sold on or about August 13, 2012);
12. Intratec TEC-DC9 9 millimeter pistol, bearing an obliterated serial number (sold on or about August 13, 2012);
13. Romarm/Cugir, WASR 10/63 .762 caliber rifle, bearing an obliterated serial number (sold on or about August 15, 2012); and
14. Hi Point Model 4095, .40 caliber rifle, bearing an obliterated serial number (sold on or about August 15, 2012).

In violation of Title 18, United States Code, Section 922(a)(1)(A) and Title 18, United States Code, Section 2.

COUNT TWO


(Sale or Transfer of a Firearm to a Previously-Convicted Felon)

On or about August 15, 2012 in Camden County, in the District to New Jersey, and elsewhere, the defendant,

ERIC J. REED,

knowingly sold or otherwise disposed of a firearm, nameley, a Romarm/Cugir, WASR 10/63 .762 caliber rifle, bearing an obliterated serial number, to Ammie Steward, knowing and having reasonable cause to believe that Ammie Steward had been convicted of a crime punishable by imprisonment for a term exceeding one year.
