

ATTACHMENT A

I, Ann M. Kolczynski, a Postal Inspector with the United States Postal Inspection Service ("USPIS"), having conducted an investigation and discussed this matter with other law enforcement officers who have participated in this investigation, have knowledge of the following facts:

1. Between on or about April 14, 2006 and on or about March 4, 2011, JORGE A. ROMAN purchased approximately 79 products in 40 separate transactions from a movie production company (the "Company") using the Company's online ordering system at a total cost of over \$2,200 in United States currency. The majority of the films produced by the Company feature prepubescent boys engaging in a variety of activities, including wrestling and showering, while completely or partially naked. The films were marketed as "naturist films from around the world." ROMAN's orders included DVDs, photo CDs, and downloadable links. All of the orders were placed under the name "Jorge A. Roman." The products that ROMAN purchased from the Company were either sent from an address in New York to ROMAN at an address in Princeton, New Jersey (the "RESIDENCE"), or made available via the internet.

2. Among the DVDs that ROMAN purchased from the Company and that were sent to the RESIDENCE were the following, which I have reviewed, and which appear to be child pornography, as defined by Title 18, United States Code, Section 2256(8):

	Product Name	Description
A	Sandy Bottoms	The movie is approximately 39 minutes and 45 seconds. The movie file begins with six prepubescent boys exploring ruins and also shows them at the beach where they are swimming, playing in the ocean and on the beach. The next scene shows the boys naked as they run into the ocean and their bare bottoms are facing the camera. Two of the boys are hoisting another into the air so that he can perform a back flip into the ocean which causes his genitals to be displayed. The boys perform summersaults and headstands on the beach which causes their genitals to be displayed. In another scene, two of the boys are naked, digging in the sand and the camera zooms in on the genitals of one of the boys.
B	Water Wiggles Going Commando: Boy Fights XI (2008)	The movie ran for approximately 1 hour and 26 minutes (1:26). The movie file begins with two prepubescent males in white underwear entering an inflatable pool containing a small amount of water. The boys begin to wrestle and pull each other's underwear off, so that they are completely naked, causing their genitals to be exposed. They continue to wrestle each other naked in the inflatable pool, and play with various objects including an inflatable float and a plastic ball. Their genitals are often displayed to the camera. The boys towel off and then

		<p>proceed to empty the water from the pool and dry the pool while they are naked. At the end of the movie file, the two prepubescent boys are standing naked facing the camera causing their genitals to be visible. The English subtitles indicate that the interviewer asks the boys their names and ages. The boys indicate that their ages are 13 years old and almost 13 years old.</p>
C	<p>Boy Fights XVIII: Commando Squared (2008)</p>	<p>The movie ran for approximately 1 hour and 4 minutes. The movie file begins with two prepubescent males who enter a home and become completely naked. The boys perform pushups, planks and sit-ups which causes their genitals to be displayed. In another scene one of the boy's hands is bound as he wrestles the other boy causing his genitals to be displayed. Throughout the movie file, the boys continue to wrestle, pillow fight and tickle each other with a feather duster. At the end of the movie file, the two prepubescent boys pose naked in front of the camera causing their genitals to be visible. The English subtitles indicate that the interviewer asks the boys their names and ages. The boys indicate that their ages are 13 years old and 12 years old.</p>
D	<p>Raw Rewind [2-disc] (2011)</p>	<p>The movie files ran for a total of approximately 2 hours and 50 minutes. The first movie file features three prepubescent boys. The three boys remove all of their clothing and walk to an indoor pool where they engage in play and swim naked. Throughout this segment, the boys are naked and their genitals are exposed. The three boys then proceed to a couch. The boys remain naked and two of the boys are depicted providing the other prepubescent boy with a massage. The movie file then reverts to a scene with four prepubescent boys in the shower, sitting on a couch, and sitting in a sauna with each other. During this segment, all of the boys are naked and their genitals are plainly visible to the camera. The second movie file features four prepubescent boys who are depicted playing and swimming in the indoor pool. All of the boys are naked and their genitals are exposed. The four boys are also depicted in the shower, sitting in the sauna, and sitting on a couch. All of the boys are naked and their genitals are plainly visible to the camera. In the third movie file, three prepubescent boys are interviewed while sitting on a couch. They are naked and their genitals are exposed. The English subtitles indicate that the interviewer asks the boys their names and ages. The boys indicate during the interview that their ages are 11 years old, 12 years old, and 12 years old, respectively.</p>

3. Investigation further determined that ROMAN resided at the RESIDENCE.

4. On or about May 16, 2013, USPIS executed a search warrant on the RESIDENCE. JORGE A. ROMAN was present at the RESIDENCE during the search.

5. Among the items recovered during the search were the four DVDs listed in paragraph 2.

6. Defendant ROMAN was interviewed by law enforcement on May 16, 2013. In substance and in part, ROMAN admitted to purchasing the DVDs listed in paragraph 5 from the Company, that the DVDs belonged to him, and that he had viewed them.
