INFORMATION

The defendant having waived in open court prosecution by indictment, the United States Attorney for the District of New Jersey charges:

On or about February 14, 2013, in Middlesex County, in the District of New Jersey, and elsewhere, defendant

MICHAEL GRENNIER

did knowingly employ, use, persuade, induce, entice, and coerce a minor female, "JANE DOE," to engage in sexually explicit conduct for the purpose of transmitting any live visual depiction of such conduct, and the visual depiction was transmitted using any means and facility of interstate and foreign commerce and in and affecting interstate and foreign commerce.

In violation of Title 18, United States Code, Section 2251(a).

FORFEITURE ALLEGATION

The United States hereby gives notice to the defendant Michael Grennier that, upon his conviction of the offense charged in this Information, the government will seek forfeiture in accordance with Title 18, United States Code, Section 2253, of (a) any visual depiction described in Section 2251, 2251A, 2252, 2252A, 2252B, or 2260 of Title 18, United States Code, or any book, magazine, periodical, film, videotape, or other matter which contains any such visual depiction, which was produced, transported, mailed, shipped or received in violation of such sections; (b) any property, real or personal, constituting or traceable to gross profits or other proceeds obtained from the offense of conviction; and (c) any property, real or personal, used or intended to be used to commit or to promote the commission of the offense of conviction or any property traceable to such property, including, but not limited to:

8192RB and BL0809NPZB, labeled "MFG";
9. One Memorex thumbdrive, labeled
"mgrennier@comcast.net";
10. One Attache PNY thumbdrive, labeled "MFG";
11. One Apple iPhone, Model A1429; and
12. One San Disk Cruzer Blade thumbdrive, Serial Numbers
SDCZ50-016G and BL1207ZMXB.

If any of the above-described forfeitable property, as a
result of any act or omission of the defendant:

(a) cannot be located upon the exercise of due
diligence;

(b) has been transferred or sold to, or deposited with, a third party;

(c) has been placed beyond the jurisdiction of the court;

(d) has been substantially diminished in value; or

(e) has been commingled with other property which cannot be divided without difficulty; it is the intent of the United States, pursuant to Title 21, United States Code, Section 853(p), as incorporated by Title 18, United States Code, Section 2253(b), to seek forfeiture of any other property of such defendant up to the value of the forfeitable property described in this forfeiture allegation.
