**INDICTMENT**

The Grand Jury in and for the District of New Jersey, sitting at Camden, charges:

**COUNTS 1-2**

**Sexual Exploitation of Children**

On or about the dates listed below, in Gloucester County, in the District of New Jersey, and elsewhere, the defendant,

GERRETT CONOVER,  
a/k/a "Peter Hansen,"  
a/k/a "petersneaks,"  
a/k/a "sneaksrcool," and  
a/k/a "plasticpvc,"

did employ, use, persuade, induce, entice, and coerce minors to engage in sexually explicit conduct for the purpose of producing visual depictions of such conduct, which visual depictions were produced and transmitted using materials that had been mailed, shipped, and transported in and affecting interstate and foreign commerce by any means, including by computer, and which visual depictions had actually been transported and transmitted using any means and facility of

interstate and foreign commerce and in and affecting interstate and foreign commerce and mailed, each constituting a separate count of the Indictment as set forth below:

**COUNTS 3 -12****Receipt and Distribution of Child Pornography**

On or about the dates listed below, in Gloucester County, in the District of New Jersey, and elsewhere, the defendant,

GERRETT CONOVER,  
a/k/a "Peter Hansen,"  
a/k/a "petersneaks,"  
a/k/a "sneaksrcool," and  
a/k/a "plasticpvc,"

did knowingly receive and distribute images of child pornography, as defined in Title 18, United States Code, Section 2256(8), that had been mailed, and using any means and facility of interstate and foreign commerce, shipped and transported in and affecting interstate and foreign commerce by any means, including by computer, each constituting a separate Count of the Indictment as set forth below:

**COUNT 13**

**Possession of Child Pornography**

On or about September 17, 2012, in Gloucester County, in the District of New Jersey, and elsewhere, the defendant,

GERRETT CONOVER,  
a/k/a "Peter Hansen,"  
a/k/a "petersneaks,"  
a/k/a "sneaksrcool," and  
a/k/a "plasticpvc,"

did knowingly possess computers and hard drives which contained three or more images of child pornography, as defined in Title 18, United States Code, Section 2256(8), which images were mailed, shipped and transported using any means and facility of interstate and foreign commerce, and in and affecting interstate and foreign commerce by any means, including by computer, and that were produced using materials that had been mailed, shipped and transported in and affecting interstate and foreign commerce by any means, including by computer.

In violation of Title 18, United States Code, Sections 2252A(a)(5)(B) and 2252A(b)(2), and Title 18, United States Code, Section 2.

**FORFEITURE ALLEGATION**


Upon conviction of the offenses alleged in Counts 1 – 13 of this Indictment, defendant Gerrett Conover shall forfeit to the United States pursuant to 18 U.S.C. § 2253, all visual depictions which were produced, transported, mailed, shipped or received in violation of the law; all property, real or personal, constituting or traceable to gross profits or other proceeds obtained from the offenses; and the following personal property used or intended to be used to commit or to promote the commission of the offenses which were seized by law enforcement officers on or about September 17, 2012 and September 19, 2012 from defendant Gerrett Conover's residence in Gloucester County, New Jersey:
