- \*2. Proposed Price. Contractor must provide the Government with a quote for the services described in Section 3.0, Statement of Work, for the Base Year and Option Year One (1). At a minimum, proposal shall address the following costs:
  - (a) Afternoon pickup/delivery charges (Section 3.1.1.).
  - (b) Fuel Charges (if applicable).
  - (c) New Mexico Gross Receipts Tax (Para 3.1.14).
  - (d) Net Daily/Monthly Charge.
  - (e) Net Annual Charge (based on 22 business days in a month).\*
2. Amendment deletes the requirement to submit proposals for Option Year 2 and Option Year 3 (Contract will be awarded as a base year with one option year).
