INDICTMENT

The Grand Jury charges:

Count 1

Between on or about June 14, 2010 and September 1, 2010, in McKinley
County, in the District of New Mexico, the defendants, **JASON JARAMILLO, LANCE
ROCHLITZ, MICHAEL GOODSON, and GEORGIA GOODSON, a/k/a Georgette**

Callaway, a/k/a Georgia Charley, a/k/a Georgia Callaway, a/k/a Georgia Calloway Charley, GILBERT ARAGON, and MATTHEW GONZALES, did unlawfully, knowingly and intentionally combine, conspire, confederate and agree with each other and with other persons whose names are known and unknown to the grand jury to commit the following offense against the United States, to wit: distribution of marijuana, contrary to 21 U.S.C. §§ 841(a)(1) and (b)(1)(D) and distribution of fifty grams and more of methamphetamine, contrary to 21 U.S.C. §§ 841(a)(1) and (b)(1)(A).

In violation of 21 U.S.C. § 846.

Count 2

On or about June 14, 2010, in McKinley County, in the District of New Mexico, the defendants, **MICHAEL GOODSON and GEORGIA GOODSON, a/k/a Georgette Callaway, a/k/a Georgia Charley, a/k/a Georgia Callaway, a/k/a Georgia Calloway Charley**, unlawfully, knowingly and intentionally distributed marijuana.

In violation of 21 U.S.C. §§ 841(a)(1) and (b)(1)(D) and 18 U.S.C. § 2.

Count 3

On or about June 16, 2010, in McKinley County, in the District of New Mexico, the defendants, **MICHAEL GOODSON, and GEORGIA GOODSON, a/k/a Georgette Callaway, a/k/a Georgia Charley, a/k/a Georgia Callaway, a/k/a Georgia Calloway Charley**, unlawfully, knowingly and intentionally distributed marijuana.

In violation of 21 U.S.C. §§ 841(a)(1) and (b)(1)(D) and 18 U.S.C. § 2.

Count 4

On or about July 6, 2010, in Cibola County, in the District of New Mexico, the defendants, **JASON JARAMILLO, LANCE ROCHLITZ, and GEORGIA GOODSON, a/k/a Georgette Callaway, a/k/a Georgia Charley, a/k/a Georgia Callaway, a/k/a Georgia Calloway Charley**, unlawfully, knowingly and intentionally distributed five grams and more of methamphetamine.

In violation of 21 U.S.C. §§ 841(a)(1) and (b)(1)(B) and 18 U.S.C. § 2.

Count 5

On or about July 30, 2010, in McKinley County, in the District of New Mexico, the defendants, **MICHAEL GOODSON, and GEORGIA GOODSON, a/k/a Georgette Callaway, a/k/a Georgia Charley, a/k/a Georgia Callaway, a/k/a Georgia Calloway Charley**, unlawfully, knowingly and intentionally distributed marijuana.

In violation of 21 U.S.C. §§ 841(a)(1) and (b)(1)(D) and 18 U.S.C. § 2.

Count 6

On or about August 5, 2010, in McKinley County, in the District of New Mexico, the defendants, **JASON JARAMILLO, LANCE ROCHLITZ, MICHAEL GOODSON, and GEORGIA GOODSON, a/k/a Georgette Callaway, a/k/a Georgia Charley, a/k/a Georgia Callaway, a/k/a Georgia Calloway Charley and GILBERT ARAGON**, unlawfully, knowingly and intentionally distributed fifty grams and more of methamphetamine.

In violation of 21 U.S.C. §§ 841(a)(1) and (b)(1)(A) and 18 U.S.C. § 2.

Count 7

On or about September 1, 2010, in McKinley County, in the District of New Mexico, the defendants, **MATTHEW GONZALES and JASON JARAMILLO**, unlawfully,

knowingly and intentionally distributed fifty grams and more of methamphetamine.

In violation of 21 U.S.C. §§ 841(a)(1) and (b)(1)(A) and 18 U.S.C. § 2.

Count 8

Between on or about June 14, 2010 and July 29, 2010, in McKinley County, in the District of New Mexico, the defendants, **MICHAEL GOODSON, and GEORGIA GOODSON, a/k/a Georgette Callaway, a/k/a Georgia Charley, a/k/a Georgia Callaway, a/k/a Georgia Calloway Charley**, did knowingly open, lease, rent, use, and maintain a place, namely residential premises at # 32 Woodview Dr., Prewitt, New Mexico, for the purpose of distributing and using a controlled substance, to wit: marijuana.

In violation of 21 U.S.C. § 856(a)(1).
