Counts 1 through 5: 18 U.S.C. §§ 2252(a)(2), 2252(b)(1), and 2256: Receipt of Visual Depictions of Minors Engaged in Sexually Explicit Conduct;

Counts 6 and 7: 18 U.S.C. §§ 2252(a)(4)(B), 2252(b)(2), and 2256: Possession of Matter Containing Visual Depictions of Minors Engaged in Sexually Explicit Conduct.

INDICTMENT

The Grand Jury charges:

Counts 1 through 5

On or about the dates set forth below, in Santa Fe County, in the District of New Mexico, the defendant, **ROBERT A. WARREN**, did knowingly receive visual depictions contained in the computer files described below, which visual depictions had been mailed and shipped and transported in interstate and foreign commerce, or which contained materials which had been so mailed and shipped and transported by any means, including by computer, the production of which involved the use of a minor engaging in sexually explicit conduct and are of such conduct:

In violation of 18 U.S.C. §§ 2252(a)(2), 2252(b)(1), and 2256.

Count 6

On or about June 18, 2007, in Santa Fe County, in the District of New Mexico, the defendant, **ROBERT A. WARREN**, did knowingly possess: a Dell XPS Tower Computer, Serial Number 38H3T71, with a Western Digital Hard Drive, containing any visual depiction that had been shipped and transported in interstate and foreign commerce or which was produced using materials which had been so shipped and transported, by any means, including by computer, the production of which involved the use of a minor engaging in sexually explicit conduct and are of such conduct.

In violation of 18 U.S.C. §§ 2252(a)(4)(B), 2252(b)(2), and 2256.

Count 7

On or about June 18, 2008, in Santa Fe County, in the District of New Mexico, the defendant, **ROBERT A. WARREN**, did knowingly possess a: Gateway Desktop Computer, Model 2000, Serial Number 0009043536, with an IBM Hard drive containing any visual depiction that had been shipped and transported in interstate and foreign commerce or which was produced using materials which had been so shipped and transported, by any means, including by computer, the production of which involved the use of a minor engaging in sexually explicit conduct and are of such conduct.

In violation of 18 U.S.C. §§ 2252(a)(4)(B), 2252(b)(2), and 2256.
