10 AFFIDAVIT

11 I, the undersigned, being duly sworn, hereby depose
12 and state as follows:

13 1. I, Mark W. Buie, am a Special Agent of the Federal
14 Bureau of Investigation (FBI) currently assigned to the Santa Fe
15 Resident Agency of the Albuquerque Division, to investigate
16 violations of Federal Laws, including Title 18, United States
17 Code, Section 2113(a). The information set forth in this
18 affidavit has been derived from my own investigation or
19 communicated to me by other sworn law enforcement officers or
20 from other reliable sources.

21 2. On August 11, 2010 at approximately 4:48 a.m., the FBI
22 in Albuquerque, New Mexico received a call from the Santa Fe
23 Police Department reporting that the First National Bank of Santa
24 Fe, a Federally insured institution, located at 2021 Cerrillos
25 Road, Santa Fe, New Mexico had been broken into and may have been
26 robbed.

1 3. At approximately 7:55 a.m. on the same morning, your
2 affiant arrived at the bank. Upon inspection of the front of the
3 bank, it appeared that an individual had attempted to gain access
4 to the Automatic Teller Machine (ATM) located on the front of the
5 bank. The ATM was severely damaged with a broken monitor and
6 tool marks as if an individual had attempted to forcibly remove
7 the machine from the wall with a tool.

9 4. Adjacent to the ATM, an exterior door to the bank
10 showed extensive damage to the areas around the bolts and
11 doorknob. The damage appeared as if an individual had forcibly
12 tried to pry open the door with a tool. On the southwest side of
13 the bank, a glass exterior door of the bank was shattered. On
14 the west wall of the bank, the night depository box had minor
15 damage, appearing as if an individual tried to gain access to the
16 box by attempting to pry the box off of the wall with a tool. In
17 a building adjacent to the bank, also a First National Bank
18 building, with an address of 2020 Rosina Street, an exterior
19 window on the east side of the building was shattered.

20
21 5. Your affiant reviewed surveillance video from the
22 bank. Surveillance video indicated that at approximately 12:07
23 a.m., a white male with short dark hair, wearing a white t-shirt
24 with writing across the front, attempted to gain access to the
25 ATM previously mentioned. A short time later, surveillance video
26 on the inside of the bank showed a white male with short dark
27 hair, wearing camouflage pattern shorts with a belt, and a plain
28 white t-shirt with writing across the front of the shirt, had

1 shattered the exterior glass door and entered the bank through
2 the southwest side. After entering the bank, the individual
3 jumped over the teller counter and attempted to access drawers
4 near the teller counters. The individual then departed the bank
5 through the shattered southwest door.

6
7 6. At approximately 8:40 a.m., Officer Joseph LeBlanc of
8 the Santa Fe Police Department was outside of the bank assisting
9 with the investigation. Officer LeBlanc noticed an individual
10 walking on the sidewalk adjacent to the bank that appeared to
11 match the description of the individual seen in the surveillance
12 video mentioned previously. The individual is described as a
13 white male with short brown hair, wearing camouflage shorts with
14 a belt and a white t-shirt with writing on the front. Officer
15 LeBlanc placed the individual into custody and brought him to the
16 affiant. Upon approaching your affiant, the individual stated,
17 "I did it, I'm gonna be honest with you." as he nodded his head
18 towards the bank. He further stated, "I'm going to be honest
19 with you, I'm sorry." This individual was identified as LUKE
20 KORZEC, year of birth, 1981, Social Security Account Number, XXX-
21 XX-1816.

22
23 7. KORZEC provided additional information about the
24 attempted robbery. KORZEC advised that on the previous night
25 (early morning) he got drunk and needed some money. KORZEC first
26 went to a chili roasting machine located on the north side of the
27 bank and broke off the handle. After obtaining the handle of the
28 chili roasting machine to use as a tool, KORZEC attempted to

1 break into the ATM located in front of the bank. KORZEC was
2 unsuccessful in obtaining any money from the machine.

3
4 8. After failing to gain access to the ATM, KORZEC
5 attempted to gain access to the bank through an exterior door
6 adjacent to the ATM. KORZEC was unsuccessful in entering the
7 bank through this door. KORZEC then went to the southwest side
8 of the bank and shattered a glass door, which also tripped the
9 burglar alarm. After entering the bank, KORZEC hopped over the
10 teller window and tried to find money in the drawers where
11 tellers keep their money. KORZEC found a key in a drawer and
12 took it. KORZEC was showed a still photograph of the individual
13 that entered the bank. KORZEC advised that the person in the
14 photograph was him. KORZEC was not able to obtain any money from
15 the bank.

16
17 9. After being interviewed, KORZEC showed the agents
18 where he had hidden the handle from the chili roasting machine
19 and the key which he had taken from the bank and these items were
20 retrieved.

21
22 Based on the information set forth in this affidavit, your
23 affiant submits that there is probable cause to believe that LUKE
24 KORZEC did unlawfully enter or attempt to enter a bank and
25 intended to commit a felony or larceny in the First National Bank
26 of Santa Fe, New Mexico on August 11, 2010.

27
28 Your affiant further submits that this attempted robber was

1 committed in violation of Title 18, United States Code, Section
2 2113(a).


