10	AFFIDAVIT	
11	I, the undersigned, being duly sworn, hereby, depose and state as follows:	
12	1. I am a Special Agent (SA) of the Federal Bureau of Investigation (FBI) and have	
13	been employed in that capacity for approximately twelve years. I am currently	
14	assigned to the Albuquerque Division of the FBI, and have primary investigative	
15	responsibility in crimes which occur in Indian Country including violent crimes such as	
16	as robbery, aggravated assaults, and homicide.	
17	2. The information set forth in this affidavit has been derived from an investigation	
18	conducted by the Navajo Nation Criminal Investigation Services (NNCIS) by Criminal	
19	Investigator (CI) Jefferson Joe of the Shiprock District, and Special Agent William Hall of	
20	the FBI, Farmington Resident Agency (FRA), as well as other law enforcement officers of	
21	the Navajo Nation Department Of Public Safety.	
22	3. On February 06, 2010 at approximately 12:15 P.M., the FRA was notified by	
23	Criminal Investigator Jefferson Joe of the NNCIS that a man's body had been found	
24	approximately one mile north of the Burnham Chapter House, Burnham, New Mexico	
25	(NM) and it appeared to be a homicide. The body was within fifty yards of a home, later	
26	identified as the residence of Darnell Begay. The incident location is within the exterior	
27	boundaries of the Navajo Indian Reservation.	
28	4. SA Hall and CI Joe responded to the scene and observed a body, later identified as

Peyton Hogue, laying on his back against an outcropping of rock. The victim had extensive trauma to his face and neck with small puncture wounds in his abdominal area. CI Joe interviewed a security guard who works at the Chapter House. The guard advised he usually sees a black Chevrolet pickup at the residence. The guard advised the truck was driven by Tyrus Begaye, a former employee at the chapter house, who had lived at the aforementioned residence while employed at the chapter house.. The guard further advised he had seen the truck near the chapter house at approximately 5:00 PM on 02/05/2010.

5. On 02/07/2010, CI Joe received a telephone call from Wayne Barnett, the
stepfather of Darnell Begay. Barnett advised that Tyrus had come to his home yesterday
and was very distraught. Barnett stated Tyrus asked his wife for money to hire an attorney.
Barnett then suggested to Tyrus that both he and Darnell turn themselves in to the
authorities.

6. On 02/08/2010, both Tyrus Begaye and Darnell Begay walked into the Navajo 13 Criminal Investigator's office in Shiprock, New Mexico. SA Hall and CI Joe interviewed 14 15 both Tyrus and Darnell. Tyrus stated that on 02/05/2010 he had purchased some beer at the Wal mart in Farmington, NM. After purchasing the beer he called his cousin Darnell 16 17 Begay, to see if he wanted to do some drinking and hang out at Darnell's home, which is located just north of the Burnham Chapter house. Darnell agreed and Tyrus then drove to 18 19 Darnell's mother's home and picked him up. They then drove to Darnell's home, built a fire 20 and began drinking. Tyrus stated that around 12:00 AM on 02/06/2010 he went outside to 21 use the out house, which is approximately 20 yards west of the home. When he went 22 outside, he advised he heard voices yelling, "fuck you". Tyrus stated he could see a 23 shadow, took his glasses off and advanced on the shadow. Tyrus stated he felt he had to 24 rush the shadow and that he began hitting him, over and over. Tyrus stated he thought he 25 saw something in his hand and grabbed his arm, all the while hitting him with his fist. (26 Investigators found no weapons at the crime scene.)

7. Tyrus stated that while he was hitting the unknown man, Darnell ran up to help
subdue the victim. Tyrus stated he held one arm and Darnell held the other, while they were

yelling and asking who he was. Tyrus advised when he wouldn't answer them, they hit him more. Tyrus stated that Darnell kicked the victim a couple of times and that during the beating the man finally said he was Peyton. Tyrus stated the victim's face was painted white 3 4 and that he kept growling while they beat him. Tyrus then said they continued to beat him 5 into confessing he was a witch, but he never did. After they beat him they told him to go away and they walked back to Tyrus' truck. They then drove to where the victim was and 6 7 observed he was sitting upright, coughing up blood. They told him to get out of there and they left. 8

8. Afraid they had hurt the victim, they then drove to Tyrus' aunt's home and she 9 prayed for them. After that, he drove Darnell to his ex-wife's home and dropped him off. 10 Tyrus advised they had initially been told by a medicine man to destroy all the clothes they 11 12 had on the night before, because they had witches's blood on them, but later recanted and stated friends had told them. On 02/07/2010, they then went to a Navajo medicine man, 13 who prayed over them and told them to turn themselves in. Tyrus stated we were was just 14 defending "our space", because someone had invaded it. Tyrus stated that even though he 15 initially attacked the victim, he felt it was in self defense, "it was his life or mine". 16 17 Tyrus showed investigators his swollen left hand, bruised right elbow, and said his right knee hurt from kneeing the victim; and, no other apparent injuries. 18

19 9. Darnell was then interviewed and he stated that the he lives part time in the house 20 north of the Burnham Chapter House. Darnell stated the home belongs to Benjamin Hogue, the uncle of the deceased victim. He advised that on 02/05/2010, he and Tyrus decided to 21 do some drinking and watch a movie at the house. Darnell stated Tyrus came and picked 22 23 him up and they drove to his home near Burnham. They built a fire and began drinking, when Tyrus decided to go outside to use the bathroom in the outhouse. Darnell stated Tyrus 24 25 yelled that someone was outside, yelling at him. Darnell went outside and at first did not 26 hear anything, then heard someone yell, "fuck you". Darnell advised he could not see who 27 it was, but told them to go away. Darnell stated he then saw someone else and chased after them. Darnell then heard Tyrus yelling and he went to help him. When he got there, the 28

victim was already on the ground and Tyrus was hitting him. Darnell advised he then held 1 the victim down while Tyrus beat him, trying to get the victim to say his name and what he 2 wanted. Darnell advised the victim had a white face and dark eyes and that he thought he 3 might be a shape shifter. Darnell advised that once the victim said his name was Peyton, he 4 5 pulled Tyrus off the victim, because he knew him and that he lived nearby. Darnell advised he had to pull Tyrus off of the victim at least three times and that Tyrus had kicked him a 6 couple times in the head. Darnell advised he only hit the victim a couple times with his fist. 7 After they had finished beating the victim Darnell advised they walked back to Tyrus' truck. 8 Darnell advised they decided to go back and check on the victim, because they were afraid 9 they had killed him. When they drove back they saw him sitting up, coughing up blood. 10 They told him to leave and they then drove away. 11

10. The next morning, Darnell stated they told his mother, Alice Begay, about the 12 fight. Alice routinely goes to the house on Saturday's to get Darnell's girl's clothing. When 13 she drove to the house, she discovered the body and subsequently reported it to the police. 14 She then called Darnell and told him the victim was dead. Darnell stated a relative told him 15 and Tyrus to destroy the clothes they wore because they had the blood of a skin walker on 16 them. Darnell stated they burned the clothes in stove in the house. This is inconsistent, as 17 they would have to have burned them the night of 02/05/2010, but were supposedly told to 18 burn them during the day of 02/06/2010. 19

11. Darnell stated they went and saw a medicine man on 02/07/2010, who prayed
over them and told them to turn themselves in. Darnell had no apparent injuries and
admitted he was never hit by the victim. Darnell estimated the beating to have lasted three
to five minutes.

24 12. Begaye is listed on the Navajo Census roll and is an enrolled member of the
25 Navajo Indian tribe.

13. Based on the information provided, there is probable cause to believe that on or
about February 05, 2010, Darnell Begay, an enrolled member of the Navajo Indian Tribe,
was within the territorial jurisdiction of the Navajo Indian Reservation when he unlawfully
