I, the undersigned complainant being duly sworn state the following is true and correct to the best of my knowledge and belief. On or about March 24, 2010 in Bernalillo county, in the state and \_\_\_\_\_ District of New Mexico defendant(s)





AFFIDAVIT

I, the undersigned, being duly sworn, hereby depose  
and state as follows:

1. I am a Special Agent (SA) of the Federal Bureau of  
Investigation (FBI) and have been employed in that capacity  
since February of 2009. I am currently assigned to the  
Albuquerque Division and have primary investigative  
responsibilities in major crimes, violent actions, and federal  
violations. The information set forth in this affidavit has  
been derived from my own investigation or communicated to me  
by other sworn law enforcement officers or from other reliable  
sources.

2. On March 24, 2010, the FBI received a referral from  
the Kirtland Air Force Base Office of Special Investigation  
(OSI). The referral alleged sexual abuse of a child. The  
allegation stated that Clifton Eugene Johnson, a step-  
grandfather to the victim, had sexually abused a juvenile

1 female, hereinafter referred to as Jane Doe. The sexual abuse  
2 took place on the morning of March 24, 2010 at the FamCamp  
3 Recreational Vehicle lot, located within the exterior  
4 boundaries of Kirtland Air Force Base, within the special  
5 maritime and jurisdiction of the United States.

6  
7 3. On the night of March 23, 2010, Jane Doe asked her  
8 parents if she could stay overnight with her grandparents.  
9 Jane Doe's family, to include some extended family, had been  
10 vacationing in Albuquerque, New Mexico and were staying in two  
11 locations on Kirkland Air Force Base. Jane Doe's family was  
12 staying in temporary housing on the Kirtland Air Force Base.  
13 Clifton and his wife, Gwen Johnson, where staying in their  
14 recreational vehicle (RV) at the FamCamp RV lot, also located  
15 on Kirtland Air Force Base. Jane Doe received permission from  
16 her parents and spent the night on a pull-out bed in her  
17 grandparent's RV.

18  
19 4. On the morning of March 24, 2010, Clifton, Gwen, and  
20 Jane Doe awoke in the RV and prepared to meet with the rest of  
21 the family at the temporary housing for breakfast. Gwen felt  
22 that Clifton and Jane Doe were taking too long so she  
23 proceeded to walk to the temporary housing, located a few  
24 blocks away. Jane Doe began taking a shower but found that  
25 the RV was out of hot water, so she dressed in cut-off jean  
26 shorts, and a wrap/robe and returned to the pull-out bed.

27  
28 5. Shortly after Jane Doe returned to the pull-out bed,

1 Clifton entered the room and began rubbing her back in a  
2 massaging manner while she sat on the bed.

3  
4 6. In an interview, Jane Doe described laying on the  
5 pull-out bed while Clifton massaged her stomach. He began  
6 moving his hands upwards, touching her breasts, and she pushed  
7 his hands away. Three times Jane Doe used her hands to block  
8 Clifton's advances towards her breasts. Jane Doe further  
9 described Clifton digitally penetrating her vagina with one of  
10 his hands. She stated that she closed her legs and he stopped  
11 touching her.



13 7. In an interview with Clifton, he described touching  
14 and rubbing Jane Doe's breasts with his hands. He further  
15 described kissing her breasts with his mouth. With his left  
16 hand, Clifton touched her pubic region and remarked to her  
17 "you're not blonde" at the sight of her pubic hair above her  
18 shorts. He recalled rubbing his hand near her pubic hair and  
19 the middle finger of his left hand touching a "wet" area in  
20 Jane Doe's pubic region.

21  
22 8. Once Clifton stopped touching Jane Doe, they both  
23 dressed and prepared to meet the family for breakfast.  
24 Clifton told Jane Doe "Don't tell anyone or we'll get in  
25 trouble."



27 9. Based on the information set forth in this  
28 affidavit, your affiant submits that there is probable cause

1 to believe that on March 24, 2010, Clifton Eugene Johnson year  
2 of birth 1944, Social Security Account Number XXX-XX-3855, did  
3 sexually abuse Jane Doe, year of birth 1994, Social Security  
4 Account Number XXX-XX-4478, through sexual acts as defined by  
5 penetration of the genital opening of another by hand or  
6 finger and that the abuse occurred in the state and district  
7 of New Mexico and within exterior boundaries of the Kirtland  
8 Air Force Base, within the special maritime and territorial  
9 jurisdiction of the United States, in violation of Title  
10 18, United States Code, Sections 7, 2241(c), and 2246(2)(C).

12 10. I swear that this information is true and correct to
