

AFFIDAVIT

I, the undersigned, being duly sworn, hereby depose
and state as follows:

1. I, David A. Kice, am a Special Agent of the Federal
Bureau of Investigation (FBI), and have been so employed for
over fifteen years. I am currently assigned to the Santa Fe
Resident Agency of the Albuquerque Field Office, to
investigate violations of Federal Laws, including Title 18,

United States Code, Section 2113(a), Bank Robbery. The
information set forth in this affidavit has been derived from
my own investigation or communicated to me by other sworn law
enforcement officers or from other reliable sources.

2. On February 12, 2011 at approximately 10:40 a.m.,
the FBI in Albuquerque, New Mexico, received a call from the
Santa Fe Police Department reporting that the Wells Fargo
Bank, a Federally Insured Financial Institution, located
inside the Albertsons Grocery Store at 3001 St. Francis

Drive, Santa Fe, New Mexico, had been robbed.

3 3. Your affiant, as well as Special Agent Christopher
4 Dotson, responded to the bank to initiate an investigation.
5 Interviews of two victim tellers revealed that a male subject
6 approached the teller windows, handed one of the tellers a
7 note stating that he had a gun, and to put the money on the
8 counter. The subject subsequently verbally told both tellers
9 that he had a gun, and to give him the money from both of
10 their drawers, which they did. The subject then departed the
11 bank on foot toward the exit doors for the Albertsons. A
12 subsequent count by bank employees revealed that the subject
13 robbed the bank of \$2862.00.

23 4. At approximately 6:00 p.m. on February 17, 2011,
24 your affiant was notified by the Santa Fe Police Department
25 that officers of that department had responded to a residence
26 on an unrelated matter and received information from the
27 occupant regarding a recent bank robbery. Special Agents
28 Dotson and Mark Buie responded to the residence, located on
Buena Vista Street in Santa Fe, and made contact with the
occupant, Alden Veneklasen. Veneklasen advised Special Agent
Dotson that her ex-boyfriend, Erik Schlenker, told her that
he had done some bad things that he did not want her to know
about, such as robbing banks and various other troubles in
Southern California. Veneklasen further told Special Agent
Dotson that within the last few weeks, while Veneklasen and

Schlenker were shopping inside the Albertson's Grocery Store
1 located on Zia Road and St Francis Drive in Santa Fe,
2
3 Schlenker told Vaneklasen that this bank would be an easy one
4
5 to rob, referring to the Wells Fargo Bank located inside of
6 the Albertson's Grocery Store. Vaneklasen also stated that
7
8 during the week following the Wells Fargo robbery of February
9
10 12, 2011, Schlenker had told her that he had received some
11
12 money and wanted to take her out to a spa. Vaneklasen
13
14 thought this was strange because Schlenker is not currently
15
16 employed.

17
18 5. Special Agent Mark Buie provided Vaneklasen with a
19
20 still photograph taken from surveillance video obtained from
21
22 the bank robbery at Wells Fargo on February 12, 2011, showing
23
24 the bank robber. Vaneklasen immediately identified the male
25
26 subject in the photograph as Schlenker and further stated
27
28 that she had seen Schlenker with the particular jacket worn
by the subject in the photograph.

6. Vaneklasen agreed to arrange a meeting with
Schlenker. During a phone conversation between Vaneklasen
and Schlenker, Schlenker advised Vaneklasen that he would
meet her at the residence of his sister, Kimberly Maschino,
located at 2044 Placita De Queda, within the next few
minutes.

7. Special Agent Dotson, accompanied by Santa Fe

Police Detective Charles Lujan, proceeded to the vicinity of
1 Maschino's residence. Upon approaching the residence,
2
3 Special Agent Dotson observed a male matching the description
4
5 of Schlenker sitting at a bus stop located on Pacheco Road.
6
7 Special Agent Dotson and Detective Lujan stopped the unmarked
8 FBI vehicle and exited approximately 25 feet south of the
9
10 subject, later identified as Erik Schlenker. Upon exiting
11
12 the vehicle and approaching Schlenker, both Detective Lujan
13
14 and Special Agent Dotson identified themselves as law
15
16 enforcement officers. Schlenker immediately began fleeing
17
18 northbound on Pacheco road. Special Agent Dotson and
19
20 Detective Lujan engaged in a foot pursuit, apprehended
21
22 Schlenker, placed him under arrest, and transported him to
23
24 the Santa Fe Police Department.

25. Special Agents Buie and Dotson, with the assistance
26
27 of Detective Lujan, created a six-picture photo array
28
containing a photograph of Erik Schlenker and five other men
with similar features and appearance. The agents met with
the victim bank tellers, and separately showed each teller
the photo array. Both tellers identified the man in
photograph number 4, Erik Schlenker, as most resembling the
man who had robbed the Wells Fargo Bank.

Based on the information set forth in this
affidavit, your affiant submits that there is probable cause
to believe that Erik Schlenker did unlawfully enter and

commit a felony in the Wells Fargo Bank, 3001 South Saint
1 Francis Drive, Santa Fe, New Mexico on February 12, 2011.




