INDICTMENT

The Grand Jury charges:

Counts 1 - 3

On or about the dates set forth below, in Santa Fe County, in the District of New Mexico, the defendant, **SHABAKA GREEN**, did knowingly receive a visual depiction contained in the computer files described below, which visual depiction had been mailed and shipped and transported in interstate and foreign commerce, and which contained materials which had been so mailed and shipped and transported in or affecting interstate and foreign commerce by any means, including by computer, the production of which visual depiction involved the use of a minor engaging in sexually explicit conduct and is of such conduct:

Count 4

On or about February 9, 2011, in Bernalillo County, in the District of New Mexico, the defendant, **SHABAKA GREEN**, did knowingly possess a iBuyPower Desktop Computer, Model X58 Pro-E, Serial Number 0B8F-4AF4-A2A3-C1EC, which contained the following internal hard drives: one Western Digital 500 GB hard Drive, Model WD5000AAKS-00A7B2, Serial Number WCASY7861801; one Hitachi 1 TB Hard Drive, Model HDS721010CLA332, Serial Number HQ05MBRA; one Hitachi 2 TB Hard Drive, Model HDS722020ALA330, Serial Number YAHMVM7V; and one Hitachi 2 TB Hard Drive, Model HDS722020ALA330, Serial Number YAHMR69V, containing a visual depiction that had been shipped and transported in interstate and foreign commerce and which were produced using materials which had been shipped and transported in or affecting interstate and foreign commerce, by any means, including by computer, the production of which visual depictions involved the use of a minor engaging in sexually explicit conduct and is of such conduct.
