9.	AFFIDAVIT			
10	I, the undersigned, being duly sworn, hereby depose and state as follows:			
11				
12	1. I am a Special Agent of the Federal Bureau of Investigation (FBI) and have been employed in that capacity for almost fourteen years. I am currently assigned to the Albuquerque Division and investigate major crimes and conduct other investigations including but not limited to violent crimes and bank robberies. The information set forth in

16	this affidavit has been derived from my own investigation or communicated to me by other			
17	sworn law enforcement officers or from other reliable sources.			
18				
19	2. On June 22, 2009, at approximately 10:04 a.m., the Bank of the West, 500			
20	Doctor Martin Luther King, Junior, Avenue, Northeast (NE), Albuquerque, New Mexico			
21	(NM), was robbed by an individual who entered the bank, verbally demanded money, and			
22	displayed a 12" kitchen knife The robber said words to the effect of, "Give hundreds and			
23	fifties." The robber also demanded money from the "refill" drawer. The teller provided the			
24	robber with a sum of United Stated Federal Reserve Bank Notes. The robber was last seen			
25	by bank personnel, getting into the passenger side of a dark green Dodge Stratus that had a			
26	missing front bumber. A woman was seen driving the Stratus. The car was last seen fleeing			
20	the bank in a southern direction.

Bank of the West is a federally insured financial institution, and did sustain a loss in United States Federal Reserve Bank Notes.

The aforementioned robbery was conducted by a man described as a Hispanic or Native American male, approximately 5'6"-5'7", dark medium complexion, medium build, dark hair and dark mustache, and approximately Mid-30s years in age. The robber was further described as wearing a white t-shirt with "TAR HEELS" in blue letters across the front, a white baseball style cap, and tan painter style pants.

3. In the evening of June 22, 2010, multiple sources called different law enforcement Agencies, and all tips consistently advised that the robber was James Joshua Abeita, year of birth 1980, Social Security Account Number (SSAN) XXX-XX-7374. The tips also advised that the James Joshua Abeita was in the presence of Adriana Nicole Abeita, year of birth 1987, SSAN XXX-XX-5971, on a near constant basis since his release from Federal Prison several weeks ago. The tips reported that Adriana owned a 2005 dark gray Dodge Stratus that was missing it's front bumper.

4. A driver's license (DL) photograph was obtained via the Motor Vehicle Division of James Joshua Abeita, year of birth 1980, SSAN XXX-XX-7374. Immediately, the writer recognized Abeita bore strong resemblance to the bank robbery in the surveillance pictures from the bank robber of the Bank of the West, 500 Doctor Martin Luther King, Junior, Avenue, NE, Albuquerque, NM, on June 22, 2010. Other Federal Bureau of Investigation (FBI) Special Agents and other local law enforcement entities compared Abeita's DL photograph and all concurred that Abeita looked like the bank robber. Abeita's new Federal Probation Officer, Jason Towne, also expressed that he believed that Abeita and the bank robber of the Bank of the West, 500 Doctor Martin Luther King, Junior, Avenue,

NE, Albuquerque, NM, on June 22, 2010, looked very much alike. Finally, the writer noticed that Abeita, in his DL photograph was wearing what appeared to be a University of North Carolina Football Jersey. The color of the "Carolina Blue" was very distinctive. The mascot of the University of North Carolina is known as the "TAR HEELS."

A six-picture photographic array was shown to three witnesses from the 5. aforementioned victim banks. Two witnesses, the victim-teller and the teller next to the victim-teller, selected James Joshua Abeita, year of birth 1980, SSAN XXX-XX-7374, as the man who robbed their bank. The third bank employee advised that he was outside 10 11 smoking and did not get a good look at the man, therefore, he could not be certain if the bank robber existed among the six pictures. 12

At approximately 3:00 pm, Isleta Pueblo Police located Adriana Nicole 6. 15 Abeita, year of birth 1987, SSAN XXX-XX-5971, and took her into custody. Shortly 16 thereafter, the writer arrived and interviewed Adriana. Adriana was read her "Advice of 17 Rights" and agreet to waive her rights and speak to the FBI and the Isleta Pueblo Police. 18

7. Adriana confessed that she had driven the getaway car and had full 21 knowledge that James Joshua Abeita, year of birth 1980, SSAN XXX-XX-7374, entered the 22 Bank of the West, 500 Doctor Martin Luther King, Junior, Avenue, NE, Albuquerque, NM, 23 on June 22, 2010, for the sole purpose of robbing that bank. Adriana advised that she and 24 James Joshua Abeita discussed robbing a bank on Sunday night, June 20, 2010, while 25 getting drunk together. Adriana advised the getaway car used was her car that she got from 26 R & J Auto in Bosque Farms, NM. 27

8. Adriana also identified that James Joshua Abeita located a key piece of evidence and Adriana observed him discarded right where it was located by the Albuquerque Police Department.
