

3. On 01/22/2014, FBI Albuquerque Division received an e-mail complaint regarding threatening, anti-Semitic notes posted on the glass door of the Nosh Jewish Delicatessen & Bakery. The two notes posted on that date read as follows:

“TO: the kikes who gave me a black eye”

“TO: The kikes who should die.”

The notes were written on self-adhesive US Priority Mail labels issued by the United States Postal Service. Jane Doe observed these threatening anti-Semitic notes placed on the front door of her business.

4. On or about 02/8/2014, two additional threatening, anti-Semitic notes were posted on Nosh Jewish Delicatessen & Bakery. These notes read as follows:

“FROM: The one who has lived with your lies.
TO: The hypocrites who bullshit the world-kikes.”

“FROM: The one you scarred for life scumbags
TO: The kikes who will die like rats.”

These notes also were written on self-adhesive US Priority Mail labels issued by the United States Postal Service. Jane Doe again found these threatening anti-Semitic notes stuck to the door of her business.

5. Jane Doe found the statements, considered them to be threatening, and quickly reported them to local enforcement and the Federal Bureau of Investigation. She conferred with family members with experience as federal law enforcement officers, who agreed that she needed to take the threats seriously. Since finding the notes, Jane Doe has taken new security precautions for Nosh Jewish Delicatessen & Bakery and has experienced fear regarding what the person responsible for the threats might do.
6. Employees saw the threatening, anti-Semitic notes that were placed on Nosh Jewish Delicatessen & Bakery on or about 01/22/2014 and 02/8/2014. These employees reported feeling afraid the business would be bombed, targeted for a shooting, or otherwise subjected to a violent attack. At least one employee altered her daily routine and purchased pepper spray to carry with her throughout her daily routine.
7. On or about 02/09/2014 other, similar notes were posted on light poles outside and near the Nosh Jewish Delicatessen & Bakery. The notes on several poles contained graffiti-

type writing with references to Judaism.

8. On 02/05/2014, Your Affiant and another FBI Special Agent met with and interviewed an employee of the Prairie Hill Apartment Complex (Employee), 1001 Tramway Blvd., Albuquerque, New Mexico. Employee noted that NG is a resident of the Prairie Hill Apartment Complex. Employee reported that on Saturday, 01/18/2014, NG came into the common area of the apartment complex and spoke with Employee. NG noted to Employee that NG had a black eye and other injuries. NG said the black eye and other injuries were received because he blacked out, "... because of those fucking Jews." He added that: "The Jews are putting something in my food. Those fucking Jews put something in my food." Referring to an elderly World War Two Veteran who lives below NG, NG added that Employee needed to "keep that fucking Jew away from me." Employee told NG that she does not think the neighbor is Jewish. NG responded that the neighbor acts like a Jew.
9. Employee read the news report of the anti-Semitic threats posted at Nosh Jewish Delicatessen & Bakery. Employee recalled that there was mention of a black eye on the notes and recalled that NG did have a black eye.
10. On 02/11/2014, Your Affiant and another FBI Special Agent interviewed NG in NG's apartment. During that interview, NG confessed to his lifelong hatred of Jews. He gave numerous examples of what he perceives as his mistreatment by Jews, beginning with a Jewish teacher he contends gave him a black eye when he was four years old living in New York. He added that a Jewish doctor diagnosed him as suffering from a bipolar mental illness. NG stated that he did not trust his doctor, because he was a Jew. NG believes that Jews have been drugging him for at least 20 years.
11. NG confessed that he twice posted notes with anti-Semitic messages on and near Nosh Jewish Delicatessen & Bakery. NG stated that he frequents restaurants, bars, and lounges in the Nob Hill area. He targeted Nosh Jewish Delicatessen & Bakery while frequenting the Nob Hill area because he believed it would be a good location to let as many Jews as possible know that they are obnoxious and self-centered, and he wanted the Jews to know "You fucking people are scum bags."
12. Located inside NG's apartment, Your Affiant observed a stack of the self-adhesive US Priority Mail labels issued by the United States Postal Service that were used to post the threatening, anti-Semitic statements outside Nosh Jewish Delicatessen & Bakery. NG

explained that these were the labels he used the two times he posted notes at the Nosh Jewish Delicatessen & Bakery, and he provided Your Affiant with one such label from his stack.

13. Your Affiant and another FBI Special Agent asked NG to stop posting notes at Nosh Jewish Delicatessen & Bakery or any other anti-Jewish notes on private or public property that did not belong to him. NG responded that he could not be sure he could stop posting notes.


14. Several days later, on or about 02/14/2014, a note with Anti-Semitic statements was found posted a vehicle parked in NG's apartment complex. The note bore a handwritten swastika and reads as follows:


"The one who knows what a kike is (to) one who is too ignorant to know they are one."

Like the notes recovered from Nosh Jewish Delicatessen & Bakery, this note was written on a self-adhesive US Priority Mail label issued by the United States Postal Service.

CONCLUSION

15. Based on the above, Your Affiant submits that probable cause exists to believe that John W. Ng committed the following offense: Interference with Federally Protected Rights by Threat, Ng, by threat of force, willfully intimidated and interfered with Jane Doe, a Jewish woman, and attempted to do so, because of her race, religion, and national origin and because Jane Doe was enjoying employment, or any perquisite thereof, by any private employer; in violation of Title 18, United States Code 245(b)(2)(c).
