

CRIMINAL COMPLAINT

I, the complainant in this case, state that the following is true to the best of my knowledge and belief.

On or about the date of _____ in the county of Kent in the _____ District of Rhode Island, the defendant violated 18 U. S. C. § 2252(A)(a)(2) & (a)(4)(B) an offense described as follows:

Knowingly received and distributed visual depictions of minors engaging in sexually explicit conduct using means of facility of interstate or foreign commerce, including by computer; and knowingly possessed one or more books, magazines, periodicals, films, videotapes and other matter which contained visual depictions of minors engaged in sexually explicit conduct that had been transported using any means or facility of interstate or foreign commerce.

AFFIDAVIT

I, Jodie Donaghy, a Special Agent with Immigration and Customs Enforcement, Homeland Security Investigations ("HSI"), hereby make this affidavit in support of a complaint against SEAN KEENER, who there is probable cause to believe: (1) knowingly received and distributed visual depictions of minors engaging in sexually explicit conduct using a means of facility of interstate or foreign commerce, including by computer, in violation of 18 U.S.C. § 2252(A)(a)(2) (Count One); and (2) knowingly possessed one or more books, magazines, periodicals, films, videotapes and other matter which contained visual depictions of minors engaged in sexually explicit conduct that had been transported using any means or facility of interstate or foreign commerce, in violation of 18 U.S.C. § 2252(a)(4)(B) (Count Two).

1. In June 2013, HSI agents in Massachusetts arrested an individual who was found to be in possession of large quantities of child pornography on flash drives. On one of one of the flash drives owned by the Massachusetts individual, HSI agents found a photo of a young girl sleeping next to a sign with the following hand-written remarks: "RHODEIslandGuy401@ Gmail :) Step daughter 3-20-2013." This photo was located in a folder entitled "Step-Daughter."

2. In the same folder entitled "Step-Daughter" in the aforementioned flash drive, agents located other photos of a young girl. One of the photos in this folder was of a young girl nude in the shower. This photo was taken from above and it appears that the girl was unaware that the photo was taken. Two other photos show a male finger pulling aside the underwear of a young girl and exposing her genitalia. These pictures clearly constitute child pornography as they depict the lascivious exhibition of the genitals of a prepubescent female. Other photos from this folder show only the bottom portion of the young girl in her underwear.

3. HSI agents searched on the internet for any information concerning the e-mail address rhodeislandguy401@gmail.com. Agents learned that the aforementioned e-mail address was linked to an account on a Russian website called IMGSRU.ru. IMGSRU.ru is a Russian owned website where individuals can store and share photographs.

4. HSI agents then examined the photos linked to the IMGSRU.ru account associated with the e-mail address rhodeislandguy401@gmail.com. One of the folders in this account was entitled: "My beautiful Step Daughter." In this folder were 6 photographs of a young girl who is identified on the website as the 7-year old stepdaughter of the account holder.

5. On November 4, 2013, Boston HSI agents sent a summons to Google, Inc. for subscriber information for the e-mail account rhodeislandguy401@gmail.com. Google responded to this summons with the following subscriber information for the aforementioned e-mail address. Name = John Write, Created On = 3/16/2013, Telephone Number = 401-250-4052.

6. Based on Google's identification of the aforementioned telephone number, a summons was sent to Sprint for subscriber information on telephone number 401-250-4052. Sprint responded that this telephone number was subscribed to by Catrina Peloquin ("Peloquin"), 3595 Post Road, Apartment 13206, Warwick, RI 02886.

7. Based on the aforementioned information, HSI agents conducted queries using commercial databases and discovered that SEAN KEENER ("Keener") lists his home address as 3595 Post Road, Apartment 13206, Warwick, RI 02886. Agents then confirmed on the Facebook page of Peloquin that KEENER is her fiancé and that she has a young daughter approximately 7 years old. The pictures of Peloquin's daughter on Facebook show the same young girl who is depicted in the photos on the Russian website IMGSRU.ru described above.

8. The Department of Motor Vehicles records indicate that Keener resides at 3595 Post Road, Apartment 13206, Warwick, RI 02886. On November 7, 2013, a Warwick, R.I. Police Detective contacted the manager of the apartment building at 3595 Post Road, Warwick. The manager stated that Peloquin, KEENER and Peloquin's young daughter have resided in Apartment 13206 for approximately the past year.

9. Based on the aforementioned information, on November 7, 2013, HSI agents obtained a warrant to search 3595 Post Road, Apartment 13206, Warwick, RI for evidence of child pornography. When agents arrived at this location that evening to execute the search warrant, agents learned that defendant KEENER had moved out of the apartment that day. Agents were then able to learn that KEENER had moved his belongings, including his computer, into a house owned by his father on Centerville Road in Warwick, R.I. At approximately 11:00 p.m. on November 7, 2013, an HSI agent obtained a warrant to search the Centerville Road location where KEENER was located for evidence of child pornography.


10. At the aforementioned residence on Centerville Road, agents located and seized an ACER computer belonging to defendant KEENER in an attached garage. A preliminary forensic analysis of this computer has revealed approximately 600 images and videos of child pornography, including images and videos depicting

prepubescent males and females engaged in sexual activity with adults.

11. Defendant SEAN KEENER was read his *Miranda* rights and agreed to waive those rights and to speak with HSI agents. Defendant KEENER told agents that he had downloaded and viewed child pornography over the internet. He also stated that he had traded images of child pornography on websites frequented by child pornographers. KEENER also admitted that he took and distributed on the internet the aforementioned photo of his girlfriend's daughter next to a sign that he wrote stating: "RHODEIslandGuy401@ Gmail :) Step daughter 3-20-2013." KEENER, however, denied that he had taken any lascivious pictures of his girlfriend's young daughter. A thorough forensic review of KEENER'S computer will be conducted.


12. There therefore is probable cause to believe that from on or about March 20, 2013 through November 7, 2013, in the District of Rhode Island and elsewhere, defendant SEAN KEENER (1) knowingly received and distributed visual depictions of minors engaging in sexually explicit conduct using a means of facility of interstate or foreign commerce, including by computer, in violation of 18 U.S.C. § 2252(A)(a)(2) (Count One); and (2) knowingly possessed one or more books, magazines, periodicals, films, videotapes and other matter which contained visual depictions of minors engaged in sexually

explicit conduct that had been transported using any means or facility of interstate or foreign commerce, in violation of 18 U.S.C. § 2252(a)(4)(B) (Count Two).
