## THE ENTERPRISE

1. At various times material to this Indictment:

1 known and unknown to the grand jury, were members and associates of an 2 organization known as the "Tycoons."

The Tycoons organization was engaged in a variety of 3 b. illegal activities, including but not limited to the prostitution of 4 minor and adult females, attempted murder, criminal threats of murder, 5 robbery, and narcotics trafficking. 6 At all relevant times, the Tycoons operated in the Southern District of California and elsewhere. 7 The organization and the individuals who associate with it 8 for criminal purposes constituted an "enterprise," as defined by Title 18, 9 United States Code, Section 1961(4) (hereinafter the "Enterprise"), 10 that is, a group of individuals associated in fact. 11 The Enterprise constituted an ongoing organization whose members functioned as a 12 continuing unit for the common purpose of achieving the objectives of 13 the Enterprise. The Enterprise was engaged in, and its activities 14 affected, interstate and foreign commerce. 15

16

## THE PURPOSE OF THE ENTERPRISE

17 2. The purposes of the Enterprise included, but are not limited18 to, the following:

a. Enriching the members and associates of the Enterprise
through, among other things, recruiting and maintaining juvenile and
adult females to work as prostitutes; the illegal distribution of
narcotics; committing robberies; and conducting other profit-driven
illegal activities in San Diego County and elsewhere;

b. Maintaining control over illegal activities occurring
in Tycoons' "territory" within San Diego County, California, including
keeping the public-at-large in fear of the Enterprise, and in fear of
its members and associates through threats of violence and violence;

C. Preserving, protecting and expanding the power of the
 Enterprise through the use of intimidation, violence, threats of
 violence, assaults, and other violent crimes as well through rap music
 and social media.

# BACKGROUND ON THE TYCOONS AND THE ROLE OF THE DEFENDANTS WITHIN

## THE ENTERPRISE

3. The Tycoons is primarily comprised of African American gang
members from cliques or subgroups distinct to the Enterprise:
Tycoons/Additup, Play Girl Fantasy (PGF) and Break Yo Bitch (BYB).

a. Tycoons/Additup: First documented in 2008 in Lemon
 Grove, a suburb of San Diego, Tycoons' members and associates
 typically operate at the Lemon Grove Trolley Station in Lemon Grove.
 Members range in age from late teens to mid-twenties.

b. Play Girl Fantasy: First documented in Spring Valley,
a suburb of San Diego, in 2004, members and associates operate at La
Presa (Spring Valley) and Grand Avenue. Members range in age from
early twenties to mid-thirties.

c. Break Yo Bitch (BYB): First documented in 2012 in Lemon Grove, a suburb of San Diego, these members and associates are typically under the age of 18 and operate in Lemon Grove at the Lemon Grove Trolley Station in the same area as Tycoons/Additup.

4. Some members of the Enterprise are also documented gang
members of several criminal street gangs within San Diego County.
These gangs include West Coast Crips, Eastside Skyline Piru (ESP),
O'Farrell Park Banksters, Lincoln Park, Emerald Hills, Neighborhood
Crips, and Cutthroats. While several of these gangs are rivals that
regularly engage in violence with each other, Enterprise members from
otherwise rival gangs assemble together to promote Tycoons' activity

1 in East San Diego County, and specifically collaborate on profitable 2 illegal activities. Members of the Tycoons come together for one 3 common goal, which is to make money through criminal acts and to raise 4 their status within the Enterprise.

The Tycoons do not follow a strict hierarchy where one 5 5. member reports to another or is directed by another member. 6 In all, the Tycoons sees itself as a "family" where all members work together 7 committing various criminal acts to make money and further support the 8 Enterprise, which is sometimes referred to as "Tycoonin" or "Adding It 9 Members of the Tycoons confer with each other on how best to Up." 10 conduct their criminal activities and assist each other with their 11 12 criminal activity.

Tycoons activities began being documented by law enforcement 13 6. as early as 2008 when law enforcement noticed a cohesive group of 14 males committing burglaries, robberies, and assaults in the cities of 15 Lemon Grove and Spring Valley. It is believed that Tycoons was formed 16 in 2008, with approximately four members. At the time, the actions of 17 most Tycoons were directed by James Terelle King, Michael 18 Dean Richardson, Andrew Damon Richardson, and an unindicted coconspirator. 19

The Tycoons claim certain areas in the cities of Lemon Grove 20 7. and Spring Valley. The boundaries in the City of Lemon Grove include 21 Interstate 94 to the North, Palm Avenue to the South, Sweetwater Road 22 to the East and Massachusetts Avenue to the West. 23 The Boundaries in the City of Spring Valley include Eucalyptus Street to the North, San 24 Carlos Street to the South, Whitestone to the East and Sweetwater Road 25 26 to the West. The Tycoons claims the lemon statue located near the Trolley Station, located at the intersection of Broadway and Lemon 27 Grove Avenue as a symbol of their gang territory. 28 The Tycoons

primarily congregate at the breezeway outside of the El Pollo Grill located at 7836 Broadway, and outside of the Starbucks located at 7801 Broadway, in the City of Lemon Grove. Members and associates are also known to congregate at Kunkle Park, also known as "Purple Park" or "Tycoon Park" located at 8105 Lemon Grove Way, Lemon Grove.

Members of the Tycoons use tattoos to identify themselves as 6 8. members of the Enterprise. These symbols include "Tycoons" or the 7 letter "T" for Tycoons, "Additup" or the letter "A" for "Additup," 8 "PGF" for "Playgirl Fantasy" and "BYB" for "Break Yo Bitch." 9 Members of the Tycoons also identify themselves by displaying hand signs 10 representing their membership. 11 Some of these hand signs include displaying a "T, " "A, " or "P." Tycoon members generally wear purple 12 which is the combination of red and blue for "Bloods" and "Crips" 13 given that many members are members or associates from various "Blood" 14 or "Crip" criminal street gangs. 15

Many members of the Tycoons claim to be "rappers" 16 9. and produce rap music and rap videos. This music raises the Enterprise's 17 status making it a symbol of success and power within the community, 18 thus assisting in recruitment of other members of the Enterprise and 19 victims of prostitution. Members of the Tycoons have created various 20 rap groups and support each other in the promotion of their music. 21 The lyrics of the Enterprise's music primarily focus on pimping 22 activity and narcotics related activity in San Diego County and across 23 the country. The lyrics also frequently contain mentions of the gang 24 lifestyle and their respective gang sets. 25

26 10. Tycoons has no set procedure to join the Enterprise. Some 27 members have joined due to their family connection or geographical 28 location. Some members have been "jumped in" which requires a new

member to be physically beaten by senior, established members of the 1 || group and demonstrate resilience during the beating. 2 Other members have been able to join due to their contribution to the Enterprise, 3 such as selling drugs, obtaining guns, selling and receiving stolen 4 5 property, "putting or in work," which includes other illegal activities. 6

7 11. The Tycoons puts much of its profit-driven Enterprise focus 8 on prostituting adult and juvenile females throughout San Diego County 9 and the United States:

10 and associates of the Enterprise acted as а. Members "pimps" (a person who befriends, recruits, trains and/or panders a 11 person for prostitution) and "bottoms" (a pimp's most trusted/senior 12 prostitute) to promote and manage prostitution activities in San Diego 13 County, California, and elsewhere. Other coconspirators facilitated 14 the Enterprise's prostitution activities, assisting Enterprise members 15 and associates in "pimping out" the adult and juvenile prostitutes. 16 Gang-controlled prostitution spawned a "pimping" subculture, known as 17 "The Game," with its own set of rules. 18

19 The Tycoons Enterprise adheres to the rules of "The b. Game," which a pimp would teach to any female he was about to "turn 20 out" or begin prostituting. Prostitutes were expected to maintain 21 absolute loyalty to their pimp, and in fact are often considered the 22 property of the pimp. Prostitutes were not permitted to speak with or 23 even look at other pimps, and may be traded or sold among the pimps. 24 Other pimps were permitted to encourage a prostitute to work for him, 25 and she was allowed to select, or "choose up," to a new pimp, though 26 generally she must pay a "choose up fee" to her new pimp for the 27 privilege. The new pimp then informed the old pimp that the 28

prostitute had decided to leave. Long-term prostitutes frequently 1 obtained tattoos, or other branding, featuring the gang moniker of 2 The rules of "The Game" also included instructions their pimps. 3 related to interactions with other prostitutes ("wifeys" or "wifeys-4 in-law"), and interactions with prostitution clients 5 ("johns" or "tricks"). 6

7 A prostitute was expected to provide her pimp with the c. money earned through her prostitution activities. 8 In exchange, the prostitute received protection, clothing, housing, cars, and food from 9 Prostitutes who attempted to carry out their business 10 her pimp. without a pimp, 11 known as "renegading," or prostitutes who were suspected of cooperating with law enforcement investigations may be 12 subject to punishment by the Enterprise and were labeled as "snitches" 13 by the Enterprise. This labeling was to encourage physical punishment 14 15 to these females. Enterprise members jointly enforced the rules of "The Game" on prostitutes who were ignoring the rules, or "out-of-16 pocket." This would typically be done through violence or threats of 17 violence. Pimps known for controlling their prostitutes through force 18 were considered "gorilla pimps," while those who convinced their 19 prostitutes to abide by the rules without violence are "finesse 20 pimps." "Finesse Pimps" usually use fraud, coercion, and emotional 21 manipulation to get their prostitutes to follow their rules. 22

d. Enterprise members and associates cooperated to promote
the prostitution activities of the Enterprise, primarily in and around
low-cost motels in Lemon Grove, Spring Valley, National City, Chula
Vista, and Mission Valley, California.

e. Members frequently pooled resources to further the prostitution activities of the Enterprise by, for instance, sharing

1 vehicles used to transport prostitutes, computers used to post advertisements, 2 and motel rooms in which the "dates" occur. Enterprise members also worked together to monitor law enforcement and 3 monitor other pimps' 4 girls. Enterprise members and associates traveled together to prostitute females in other states. 5

Enterprise members and associates also worked together 6 f. to recruit new prostitutes. Recruitment efforts generally focused on 7 vulnerable females, particularly those from a broken home or runaways. 8 Both pimps and their "bottoms" recruited new prostitutes from local 9 middle and high schools. 10 To "turn out" or initiate a new prostitute, pimps and bottoms utilized various methods to manipulate the woman, 11 including false promises of a luxurious lifestyle, intimidation, and 12 actual or threatened violence. Pimps regularly furnished drugs and 13 alcohol to lower the recruited prostitute's inhibitions and increase 14 her productivity. 15

16 12. At various times material to this Indictment, the defendants 17 had the following roles in the Enterprise.

18 Tycoons Enterprise Members: Defendants JAMES TERELLE a. Each Tycoon member 14 may be a "Big Homie" or "Lil' Homie" within the Enterprise. 15 Members were expected to "hustle" on behalf of the Enterprise, with their 16 efforts focused upon a variety of profit-making illegal activity, 17 including drug trafficking, robberies, extortion and, in recent years, 18 the prostitution of juvenile and adult females. To protect and expand 19 these illegal ventures, members defend Enterprise territory against 20 competing gangs, cooperate to detect and avoid law enforcement, and 21 intimidate members of the community. 22

b. Tycoons Enterprise Associate: Defendant CHRISTAL MARIE
TORRES, aka "Christal Cash" is an associate of the Tycoons Enterprise.
She is a "bottom" or "bottom bitch" for pimp members of the Enterprise
who assists the pimp members in recruiting and training other females

to work as prostitutes, and provide logistical support like computers,

1 online accounts and pre-paid credit cards for the new prostitutes and 2 other pimps.

# THE MEANS AND METHODS OF THE ENTERPRISE

13. Defendants and their coconspirators and associates used the
following methods and means, among others, to conduct and participate
in the conduct of the affairs of the Enterprise:

7 a. Defendants used the Enterprise to promote and expand
8 their prostitution of juvenile and adult females. Tycoons Enterprise
9 members used their status and reputation as gang members to further
10 the Enterprise's illegal prostitution activities.

b. Members and associates of the Enterprise, acting as
pimps, bottoms, and other coconspirators, solicited, enticed, coerced
and persuaded adult and juvenile females from various locations where
minors congregate, to work for them as prostitutes. Members of the
Enterprise also conducted online recruitment through social networking
websites like Instagram, Facebook, and Twitter, as well as through
other previously recruited prostitutes.

c. Members of the enterprise, acting as pimps and bottoms,
instructed prostitutes on the "rules of the game," which are rules
that prostitutes are expected to obey without question.

d. Members of the Enterprise, acting as pimps, controlled
their females, and punished them if they broke the rules set by the
pimp. Punishment included physical beatings, verbal lashings and
other humiliating acts towards the prostitute.

e. Members of the Enterprise, acting as pimps, sold, or traded prostitutes to other pimps, and females working as prostitutes were forced to work for the receiving pimp.

f. Members of the Enterprise, acting as pimps, transported
 female prostitutes to various locations in San Diego County and
 elsewhere in the United States, including known areas of prostitution
 (called "tracks" or "blades"), private residences, hotels and motels
 that would facilitate such activity and places and events with large
 customer base such as professional sporting events.

g. Members of the Enterprise, acting as pimps, transported
their female prostitutes across state lines, to states including, but
not limited to Texas, Arizona, Kansas, Michigan and Nevada.

h. Members of the Enterprise, acting as pimps, bottoms and
coconspirators, provided logistical support for each other, including
but not limited to renting motel rooms for one another, transporting
prostitutes for each other, sharing computers, data, mobile internet
connections, online accounts (like Backpage.com) and prepaid credit
cards to post prostitution ads.

i. Members of the Enterprise also shared prostitution
 intelligence such as what areas to work and what websites will
 generate the most business.

j. Members of the Enterprise, acting as pimps, directed adult and juvenile prostitutes working for them to rent hotel and motel rooms to use as temporary residences for the pimps and prostitutes as well as to commit acts of prostitution.

k. Members of the Enterprise, acting as pimps, provided to, and directed others to provide for, their prostitutes specific items to further their prostitution activity, including cellular telephones, laptop computers, wireless internet connections, prepaid credit cards and condoms.

1. Members of the Enterprise, acting as pimps, directed
 2 adult and juvenile females working for them to engage in sex acts with
 3 clients for money, and then required the females to provide the money
 4 earned to the pimp.

5 m. Members of the Enterprise, acting as pimps, threatened 6 and used force to coerce the females working as prostitutes into being 7 compliant, to protect the monies they received from prostitutes, and 8 to protect and to expand their territory to work prostitution.

n. Members of the Enterprise, acting as pimps, provided
 controlled substances, as well as alcohol, to the females working as
 prostitutes, to manipulate their loyalty and increase productivity.

12 o. Members and associates of the Enterprise committed
13 robberies to generate income.

p. Members and associates of the Enterprise engaged in the
 trafficking of controlled substances to generate income.

16 the Enterprise committed, q. Members of attempted to commit, and threatened to commit acts of violence to protect and 17 expand the Enterprise's criminal operation, and to intimidate the 18 general public. 19 These acts included attempted murder, assaults, intimidation, and threats of violence directed against rival gang 20 members, members of law enforcement, and witnesses in criminal cases. 21

23 14. Beginning in or about 2008, and continuing up to and including the present, within the Southern District of California and 24 elsewhere: Defendants JAMES TERELLE KING, aka "Tkeezin", aka "TK", aka 25 "John'te Avery King-Chambers", aka 26 "Terelle King", aka "Terelle Keezin"; MICHAEL DEAN RICHARDSON, aka "Geezo", aka "Mike Geezo", aka 27 "Mike 28 Gee-ofied", aka "M-Geezo", aka "Europeangeez", aka

California Penal Code, Sections 182, 187, 422 and 664; 5 Acts involving robbery in violation of California Penal 6 b. Code, Sections 182, 211, 212.5, 664; 7 8 c. Acts involving drug trafficking in violation of California Health and Safety Code, Sections 11351.5, 11352, 11359, 9 11360, 11378, 11379; 10 and multiple acts indictable under the following provisions of federal 11 12 law: 13 d. Title 18, United States Code, Section 1591 (sex trafficking of children 14 or by force, fraud. and 15 coercion); Title 18, United States Code, Section 1952 (interstate 16 e. 17 and foreign travel or transportation aid in of 18 racketeering); Title 18, United States Code, Section 1956 19 f.
