I N D I C T M E N T

Title 18, U.S.C., Secs. 922(g)(1) and 924(a)(2) - Felon in Possession of a Firearm; Title 18, U.S.C., Sec. 924(d)(1), and Title 28, U.S.C., Sec. 2461(c) - Criminal Forfeiture

The grand jury charges:

Count 1

On or about November 7, 2013, within the Southern District of California, defendant CU VAN HUYNH, aka Ku Van Huynh, aka Van Cu Huynh, being a person who had previously been convicted in a court, that is, the Superior Court of California, County of San Diego, of a crime punishable by imprisonment for a term exceeding one year, that is, on or about January 5, 2012, of Possession of a Controlled Substance, in violation of California Health & Safety Code, Section 11350(a), did knowingly and unlawfully possess in and affecting commerce ammunition, that is, twenty-six rounds of

1 9mm ammunition (12 rounds S&B; 6 rounds FC; 3 rounds RP; 2 rounds
2 Blazer; 2 rounds Winchester; 1 round C&C); in violation of Title 18,
3 United States Code, Sections 922(g)(1) and 924(a)(2).

4 FORFEITURE ALLEGATIONS

5 1. The allegations contained in Count 1 are realleged and by
6 their reference fully incorporated herein for the purpose of alleging
7 forfeiture to the United States of America pursuant to the provisions
8 of Title 18, United States Code, Section 924(d) and Title 28, United
9 States Code, Section 2461(c).

10 2. Upon conviction of the offense alleged in Count 1, defendant
11 CU VAN HUYNH, aka Ku Van Huynh, aka Van Cu Huynh, shall forfeit to the
12 United States, pursuant to Title 18, United States Code,
13 Section 924(d), and Title 28, United States Code, Section 2461(c), all
14 firearms and ammunition involved in the commission of the offense,
15 including, but not limited to the following:

16 a. twenty-six rounds of 9mm ammunition (12 rounds S&B;
17 6 rounds FC; 3 rounds RP; 2 rounds Blazer; 2 rounds
18 Winchester, 1 round C&C).


19 All pursuant to Title 18, United States Code, Section 924(d)(1), and
20 Title 28, United States Code, Section 2461(c).


