U.S. ATTORNEY'S OFFICE SOUTHERN DISTRICT OF OHIO CO-HOSTS FIRST-OF-ITS-KIND TOWN HALL



More than 60 New American community leaders gathered in Columbus April 23 to talk about a variety of civil rights issues.

For the first time in Ohio, community leaders representing recent immigrants in Hispanic, Asian, and African communities gathered to talk about issues like language access rights, housing rights, hate crimes, employment rights, and police relationships.

The U.S. Attorney's Office for the Southern District of Ohio, the Ohio Latino Affairs Commission, the Ohio Asian American Pacific Islander Advisory Council, and the Columbus Community Relations Commission hosted a civil rights summit for New American community leaders at the Riffe Center in Columbus on April 23.

Community leaders set the agenda by completing a survey about priority issues. Then, they were able to share dialogue with officials from the U.S. Attorney's Office, Ohio Civil Rights Commission, U.S. Department of Health and Human Services Office for Civil Rights, U.S. Equal Employment Opportunity Commission, FBI, and Department of Housing and Urban Development. They talked with local judges, law enforcement officers, and Columbus Mayor Michael B. Coleman.

The host agencies are now creating a database of existing civil rights resources for New American communities statewide.

REMEMBERING MISSING AND EXPLOITED CHILDREN

U.S. Attorney Carter Stewart joined Reynoldsburg City Council member Cornelius McGrady III and Vicki Germann from the Ohio Attorney General's office May 22 at Reynoldsburg High School in recognition of National Missing Children's Day. Germann said there were 18,219 reports of missing children in Ohio in 2012.

U.S. ATTORNEY REVISES GUN CRIME GUIDELINE

While violent crime is down in Ohio, many communities continue to suffer from the physical, financial and emotional impact of gun violence.

Federal and local prosecutors are working with law enforcement agencies and community groups to sharpen the enforcement side of the effort to reduce gun violence. One of the items mentioned most frequently by community groups is the need to coordinate prosecution efforts. Federal gun laws prohibit people who have been convicted of a felony in federal or state courts from ever having a firearm. U.S. Attorney Carter Stewart has amended the office's prosecution guideline provision for felons in possession of firearms to reflect the office's ongoing efforts to more aggressively address individuals who illegally possess firearms.

The amended guideline for 18 U.S.C. section 922(g) cases provides an additional, broader provision which takes into consideration individuals (felons) who have been convicted of a total of **three** or more state charges of carrying a concealed weapon and/or weapons under disability **and** a crime of violence on their record.

"This change helps us focus in on those who have already shown a propensity for violence and punish those who illegally carry firearms," Stewart said.

STEWART, HILL TO EDUCATE COMMUNITY ON INTERNET SAFETY THROUGH DALMAR TV



Assistant U.S. Attorney Heather Hill recently recorded a segment on Internet safety at Dalmar TV, Central Ohio's Somali television station.

U.S. Attorney Carter Stewart, Assistant U.S. Attorney Heather Hill, and Sergeant Dan Johnson from the Franklin County Sheriff's Office recently recorded TV segments to air on Dalmar TV. The trio talked about the realities of online risks, particularly focusing on child predators and child pornography. They offered case examples and safety tips for parents.

Dalmar TV is the first Somali language television network in the United States. Its prerecorded programs currently reach approximately 64,000 households in Central Ohio. Thanks to Mahad Hassan, Mohamed Mohamed, and the Dalmar TV crew, the community will be informed about ways to keep themselves and their families safe online.
