GENERAL INFORMATION AND INSTRUCTIONS

UST Form 101-7-NDR ("NDR") must be filed by the chapter 7 trustee as a virtual docket text entry with the United States Bankruptcy Court for all no-asset cases closed on or after April 1, 2009.

Version 3.3 of CM/ECF contains the virtual docket event described herein. CM/ECF will automatically compute the length of time a case has been pending. The dollar amounts are taken from the information on the debtor's Schedules, which is captured by the court as part of the CM/ECF case opening process. The trustee is not required to manually enter information from the Schedules if the data is not in the court's CM/ECF system by the time the trustee files the NDR. The trustee is not required to verify the accuracy of the pre-populated information supplied through CM/ECF.

The NDR virtual docket text entry shall include the following key information about the case as reported in the Schedules filed by the debtor(s) or otherwise found in the case record. All dollar amounts must include cents (x.xx). The date format to be followed is mm/dd/yyyy.

Data Definitions

Length of Time Pending	Number of months from the date the case was filed under chapter 7, or converted to chapter 7, to the date the NDR is filed with the court. Round to the nearest month.
Assets Abandoned	Value of assets listed on Schedules A and B minus the value of Schedule C exemptions.
Assets Exempt	Value of exemptions listed on Schedule C.
Claims Scheduled	Sum of claims listed on Schedules D, E, and F.
Claims Asserted	Not applicable.
Claims Discharged Without Payment	Same as Claims Scheduled (do not correct for nondischargeable debt or errors such as duplicate claims and wrong amounts listed by the debtor). The virtual text entry for this item appears as "Claims scheduled to be discharged without payment."

Supplemental Data Definitions

For cases in which minimal funds were collected but which were insufficient to administer, enter the dollar amount of funds collected in the field provided in the "Min Funds" CM/ECF virtual docket event.

For cases which were dismissed, converted to another chapter, or reassigned and in which no funds were collected, choose the "Dismiss/Convert No Funds" CM/ECF virtual docket event and enter "Not Applicable" for Assets Abandoned, Assets Exempt, Claims Scheduled, Claims Asserted, and Claims Discharged Without Payment.

For cases which were dismissed, converted to another chapter, or reassigned and in which funds were collected, enter the dollar amount of funds collected in the field provided in the "Dismiss/Convert Funds" CM/ECF virtual docket event, and enter "Not Applicable" for Assets Abandoned, Assets Exempt, Claims Scheduled, Claims Asserted, and Claims Discharged Without Payment.
