 PERMANENTLY ENJOINING

20 As stated by the parties in the Stipulation for Entry of Final Order and
 21 Judgment,

22 1. Plaintiff, United States of America, commenced this civil action by
 23 filing the United States’ “Complaint To Enjoin Defendant From (1) Preparing and
 24 Filing Tax Returns, Or Aiding And Assisting In The Preparation and Filing Of Tax
 25 Returns, Or (2) Representing Clients Before Internal Revenue Service.”

1 2. Defendant, Imelda Sanchez, d.b.a. Imelda Sanchez Bookkeeping &
2 Tax Services, LLC, admits the allegations of the Complaint, consents to entry of a
3 Final Order and Judgment of permanent injunction without further notice, waives
4 the entry of findings of fact and conclusions of law, and waives any right she may
5 have to appeal.

6 3. The Court has jurisdiction over this action pursuant to 26 U.S.C. §§
7 7401, 7402(a), and 7407, and 28 U.S.C. §§ 1340 and 1345.

8 NOW, THEREFORE, in accordance with the parties' stipulation described
9 above, it is ORDERED, ADJUDGED and DECREED that:

10 4. Imelda Sanchez is permanently enjoined from:

- 11 a. Preparing and filing income tax returns (acting as an income tax
12 return preparer within the meaning of Section 7701(a)(36) of
13 the Internal Revenue Code);
- 14 b. Taking any action in furtherance of aiding, assisting, advising,
15 preparing, or filing for compensation tax returns of third-party
16 taxpayers; or
- 17 c. Representing taxpayers before the Internal Revenue Service.


