

Workstation Configuration Selection Form

Below is a description of each workstation configuration. We will be inquiring which one best suits your needs.

Kiosk Assembly Configuration 1 – Separate Workstations with a Cabinet

Hardware and Software:

- DOJ will provide a personal computer (PC) with the Biometric Date Capture (BDC) application to access NGI, a set of web browsers (to access LEEP, N-DEx, and NICS), monitor, keyboard, mouse, livescan, camera, flatbed scanner, printer, and power supply.
- The Tribe will provide a separate personal computer and DOJ will install the OpenFox Messenger (OFM) application on it to access NCIC / Nlets.

<u>Cabinet:</u>

- DOJ will provide a cabinet that will "house" the following items: DOJ PC, monitor, keyboard, mouse, livescan, camera, and power supply.
- The Tribe will provide table or desk for the flatbed scanner and printer.
- The Tribe will provide another table or desk for the Tribe's PC.

Configuration 1 is suitable if the Tribe wants to have NCIC / Nlets access in a separate location (e.g., a dispatch center) from where bookings and sex offender registration is done (e.g., police department).

Kiosk Assembly Configuration 2 – Separate Workstations, No Cabinet

Hardware and Software:

- DOJ will provide a personal computer (PC) with the Biometric Date Capture (BDC) application to access NGI, a set of web browsers (to access LEEP, N-DEx, and NICS), monitor, keyboard, mouse, livescan, camera, flatbed scanner, printer, and power supply.
- The Tribe will provide a separate personal computer and DOJ will install the OpenFox Messenger (OFM) application on it to access NCIC / Nlets.

Cabinet:

- DOJ will not provide a cabinet.
- The Tribe will provide table or desk for the DOJ PC and equipment provided by DOJ.
- The Tribe will provide another table or desk for the Tribe's PC.

Configuration 2 is suitable if the Tribe wants to have NCIC / Nlets access in a separate location (e.g., a dispatch center) from where bookings and sex offender registration is done (e.g., police department).



Kiosk Assembly Configuration 3 – Single Workstation with a Cabinet

Hardware and Software:

 DOJ will provide a personal computer (PC) with the Biometric Date Capture (BDC) application to access NGI, the OpenFox Messenger (OFM) application to access NCIC / Nlets, a set of web browsers (to access LEEP, N-DEx, and NICS), monitor, keyboard, mouse, livescan, camera, flatbed scanner, printer, and power supply.

Cabinet:

- DOJ will provide a cabinet that will "house" the following items: DOJ PC, monitor, keyboard, mouse, livescan, camera, and power supply.
- The Tribe will provide table or desk for the flatbed scanner and printer.

 DOJ will provide a personal computer (PC) with the Biometric Date Capture (BDC) application to access NGI, the OpenFox Messenger (OFM) application to access NCIC / Nlets, a set of web browsers (to access LEEP, N-DEx, and NICS), monitor, keyboard, mouse, livescan, camera, flatbed scanner, printer, and a power supply.

Cabinet:

- DOJ will not provide a cabinet.
- The Tribe will provide table or desk for the DOJ PC and all of the equipment provided by DOJ.
