THE GRAND JURY CHARGES:

COUNTS 1-2
Theft of Mail
(18 U.S.C. § 1708)

On or about the dates below, in the District of Arizona, each instance being a separate count, defendant AMBER NICOLE LAMB, did steal and take from a mail route, the following parcels:

In violation of Title 18, United States Code, Section 1708.

COUNT 3
False Impersonation of a Federal Officer
(18 U.S.C. § 912)

On or about December 11, 2017, in the District of Arizona, defendant AMBER NICOLE LAMB, falsely assumed and pretended to be an officer and employee acting under the authority of the United States, and a department and agency thereof, that is, a United States postal worker, and in acting as a postal worker she obtained a thing of value, namely mail packages addressed to S.P.

In violation of Title 18, United States Code, Section 912.

COUNTS 4-6
Possession of Stolen Mail
(18 U.S.C. § 1708)

On or about the dates below, in the District of Arizona, each instance being a separate count, defendant RANDY MITCHELL KINNY, did knowingly and unlawfully have in his possession mail and the contents of mail, which had been stolen, taken, embezzled, and abstracted from the United States mail, knowing the same to have been stolen, taken, embezzled, and abstracted, as follows:

COUNT 7

**Possession with Intent to Distribute Methamphetamine
(21 U.S.C. § 841(a)(1) and (b)(1)(C))**

On or about January 5, 2018, in the District of Arizona, defendant, RANDY MITCHELL KINNY, knowingly and intentionally possessed with intent to distribute a mixture or substance containing a detectable amount of methamphetamine, its salts, isomers, and salts of isomers, a Schedule II Controlled Substance.

In violation of Title 21, United States Code, Section 841(a)(1) and (b)(1)(C).
