In relevant part, Section 1001 makes it a crime in any matter within the jurisdiction of the executive branch of the United States Government, to make "any false, fictitious or fraudulent statements or representations," or to make or use "any false writing or document knowing the same to contain any false, fictitious or fraudulent statement or entry." Violations of Section 1001 may be punishable by a term of imprisonment up to eight years.
