The Grand Jury charges:

FIRST COUNT:

On or about October 29, 2011, within the District of Columbia, Alphonso Dewayne Owens engaged in a sexual act with D.M., that is, penetration of D.M.'s vulva by Alphonso Owens' penis, by using force against D.M. and by threatening and placing D.M. in reasonable fear that she would be subjected to death, bodily injury, and kidnapping. (First Degree Sexual Abuse, in violation of 22 D.C. Code, Section 3002(a)(1) and 3002(a)(2) (2001 ed.))

The Grand Jury Further Charges that at the time Alphonso Dewayne Owens committed the offense of First Degree Sexual Abuse as charged in this count, the victim, D.M., was under the age of twelve years.

The Grand Jury Further Charges that Alphonso Dewayne Owens is or has been found guilty of committing sex offenses against 2 or more victims.

(First Degree Child Sexual Abuse, in violation of 22 D.C. Code, Section 3008 (2001 ed.))

The Grand Jury Further Charges that at the time Alphonso Dewayne Owens committed the offense of First Degree Child Sexual Abuse as charged in Count Two, the victim, D.M., was under the age of twelve years.

The Grand Jury Further Charges that Alphonso Dewayne Owens is or has been found guilty of committing sex offenses against 2 or more victims.

(First Degree Child Sexual Abuse (Aggravating Circumstances), in violation of 22 D.C. Code, Sections 3008, 3020(a)(1), 3020(a)(5) (2001 ed.))

## THIRD COUNT:

On or about October 29, 2011, within the District of Columbia, Alphonso Dewayne Owens engaged in a sexual act with D.M., that is, penetration of D.M.'s vulva by Alphonso Owens' finger with the intent to abuse, humiliate, harass, degrade, and arouse and gratify the sexual desire of any person, by using force against D.M. and by threatening and placing D.M. in reasonable fear that she would be subjected to death, bodily injury, and kidnapping. (First Degree Sexual Abuse, in violation of 22 D.C. Code, Sections 3002(a)(1) and 3002(a)(2) (2001 ed.))
